# SPORTS MEDICINE ADVISORY COMMITTEE

KSHSAA staff member Brent Unruh, ATC, reported on the April 21st meeting of the KSHSAA Sports Medicine Advisory Committee providing data regarding the second-year data on concussions reported. Additionally, the board received information regarding communications relative to the updated PPE, cold water immersion guidelines, mental health issues, and cold weather protocols.

#### NFHS NETWORK REPORT

Assistant Executive Director Jeremy Holaday updated the Executive Board on the first year of partnership with the NFHS Network.

# PUBLIC PRIVATE SCHOOL DISCUSSION

The Executive Board discussed the continuing work regarding the disparity of championships earned (proportionally) between public and private high schools. The Board reviewed updated action steps and timeline for the distribution of a survey developed by an independent researcher, the distribution of an accountability report for private and public schools, and the projected timeline to achieve the goal of forming a work group to develop specific implementation guidelines for presentation to the Board of Directors.

# KANSAS MUSIC EDUCATORS ASSOCIATION ADVISORY COMMITTEE

The Kansas Music Educators Association (KMEA), represented by Gae Phillips, Columbus; Mark Gard, Coffeyville-Field Kindley; Gretchen Bixler, Goddard-Eisenhower, and Dana Hamant, Friends University met with the Executive Board. While the KMEA had no proposals to present, the Executive Board expressed their thanks and appreciation for the efforts of KMEA to advance music education for the benefit of all Kansas students.

# KANSAS SPEECH COMMUNICATIONS ASSOCIATION ADVISORY COMMITTEE RECOMMENDATIONS

The Kansas Speech Communications Association (KSCA), represented by Steve Harrell, Tonganoxie; Larissa Marinell, Lansing; and Eric Skoglund, Olathe Northwest; met with the Executive Board to present KSCA recommendations.

The following recommendations were approved for immediate implementation:

#### Proposal #1

#### **Forensics**

Amend State Festival Qualification numbers to the following:

• 6-10 entries: 1st and 2nd qualify

• 11-15 entries: 1st, 2nd, 3rd, and 4th qualify

• 16-19 entries: 1st, 2nd, 3rd, 4th, and 5th qualify

• 20+ entries: 1st, 2nd, 3rd, 4th, 5th, and 6th qualify

#### Rationale:

• This proposal would slightly lower the standards for qualification to state festival with an aim of increasing participation in this event.

#### Proposal #2

#### **Forensics**

Change the last date for extemp topic selection from April 1 to April 15.

#### Rationale:

• The original timeline made sense in a world where questions were written by hand, mailed on paper to KSHSAA, printed at the KSHSAA office, and then distributed in boxes to each state championship site. Technology has enabled this process to speed up considerably, so the date should be moved later to accommodate for rapidly changing news and decrease the probability of students receiving questions which are no longer relevant, timely, or correct.

#### Proposal #3

#### **Debate**

For policy and Lincoln-Douglas debate, KSHSAA should adopt evidence rules, using the National Speech and Debate Association's Unified Manual as a model, to address (a) responsibilities of contestants reading evidence, (b) distortion of evidence, (c) procedures for addressing evidence violations, and (d) penalties for evidence violations.

#### Rationale:

• The manual does not currently have adequate protection against falsification of evidence, "clipping" (misrepresenting what portion of evidence was read into the round), or distorting evidence. The NSDA rules, with some modifications to account for other Kansas rules, have been in effect for several years now and serve as an effective model.

### Proposal #4

#### **Forensics**

Change the rules in prose and poetry in the following three ways:

- 1. Add to the poetry rules: "Poetry may be in free verse."
- 2. In prose and poetry, change the wording in Section 3C from "shall not" be memorized to "need not" be memorized. As a result, Section 3 instructions currently stating "shall be read from the printed manuscript" would be changed to "shall be presented from the printed manuscript."
- 3. In prose and poetry, change "Since the contestant will be holding a manuscript, the manuscript should be an integral part of the performance to "the manuscript may be an integral part of the performance."

#### Rationale:

• Some judges are confused by the inclusion of free verse presentation in poetry; explicitly stating that it is a permitted form of poetry will help to prevent grievances on that point. Two other minor rule changes are proposed to reflect more options for student performance and to account for the fact that by state championships, most performers in these events do have their work memorized.

#### Proposal #5

#### **Forensics**

Add a section to "Time Procedures and Penalties" (currently on pages 25-26 and 32-33) that reads: "If a tablet, laptop, or similar viewable electronic device is made available to the timekeeper, the screen with a running clock may be displayed to the competitor during their performance in lieu of time cards. The competitor may request that time either count up or down depending on their preference."

#### Rationale:

• The timekeeping rules currently in the manual are reflective of a time when timekeepers were typically using dedicated stopwatches or similar devices. This rule change permits a wider range of options for timekeepers, including a digital display which can be made visible to the performer.

#### Proposal #6

#### **Forensics**

Prep time in Lincoln-Douglas debate should be increased to 4 minutes per side.

#### Rationale:

• NSDA changed from 3 to 4 minutes of prep time several years ago. This has caused some conflict at invitational tournaments where some expect KSHSAA rules and some expect NSDA rules. Independently, increasing prep time results in deeper, more informed debates of a higher caliber.

# KANSAS COACHES ASSOCIATION ADVISORY COMMITTEE RECOMMENDATIONS

The Kansas Coaches Association (KCA), represented by Rod Clay, Everest; Jeri Brummett, Rock Creek; Jackie Hall, Uniontown; Steve Curran, Girard; Stan Boggs, Dodge City; and Ginny Honomichl, Baldwin City; met with the Executive Board to present KCA recommendations.

All recommendations were tabled until the June Executive Board meeting for final action. A list of the KCA proposal items follows:

#### Proposal #1

#### **Bowling**

Remove jewelry from the inappropriate attire list in the KSHSAAmanual. This would not include smart watches, as they will fall under the category of cellular devices.

#### Rationale:

- Jewelry does not inhibit an athlete from competing in the sport of bowling. Therefore, jewelry should be removed from the inappropriate attire list.
- By striking this from the KSHSAA manual, the decision of wearing jewelry will be left to the discretion of the coach.

#### Proposal #2

#### Football (8-player)

Change the format of Districts to place teams into 1st round pools of four. The 1st round pool will still be seeded as a 1v4, 2v3 match up with the winners moving on to face each other in the 2nd round. There will be one team from each district making up these pools of four teams. The district assignments, district point system, and cross-district alignments would not be changed at all.

#### Rationale:

• This format will bring new cross-district matchups into the 2nd round of the playoffs and push any potential district rematch back to the Sectional round.

### Proposal #3

#### Golf

Boys and Girls Golf - Before Regional teams are assigned, schools let KSHSAA know if they are bringing a full team or not. For Girls by SCW 13 and Boys by SCW 43.

#### Rationale:

 KSHSAA could assign an even number of full teams per Regional.

#### Proposal #4

#### Golf

Boys and Girls Golf – Allow up to two salaried coaches to coach at Regional and State.

#### Rationale:

- There are now more 1A teams with the change in classifications.
- Coaches can now coach anywhere except the green, the assistant coaches would like to be able to coach during tournaments. All other sports allow assistant coaches to coach, they would like to be able to do the same.

#### Proposal #5

#### Golf

Manual Change Recommendation: USGA local rule at girls Regional and State sites for Lost Ball and Out of Bounds.

#### Rationale:

 Pace of play and consistency. Girls have been playing by those rules during the season and this would keep rules the same.

#### Proposal #6

#### **Tennis**

Eliminate the current rule concerning caps and visors being worn forward. Depending on sunny and/or windy conditions, players often flip their hats around when they change ends of the court. Hats/Visors are to be worn either forward or backwards. They may not be worn inside out nor with the bill worn to the side.

#### Rationale:

• This has been an ongoing proposal. The coaches and Ms. Cheryl Gleason supports the change.

## Proposal #7

#### **Tennis**

Replace the current language in the tennis manual to read: "A player or doubles team is allowed one 10 minute time out per match."

#### Rationale:

• To simplify the administration of the rule for the tournament director and coaches.

#### Proposal #8

#### **Tennis**

Add "Before 12 point Tiebreaker - 90 seconds max.

#### Rationale:

• The tiebreaker determines who wins the set and or match. Coaches often times may have more than one match playing on site or at another site. This allows the coach to talk with their players at a crucial time and may be the only opportunity the coach has had to talk to the players.

#### Proposal #9

#### Wrestling

Girl Wrestlers weigh in wearing their Competition Singlet/2piece uniform, the same way girls do for USA Wrestling and other national events currently.

#### Rationale:

• This would allow any official to weigh in girl wrestlers.

## KIAAA ADVISORY COMMITTEE RECOMMENDATIONS

The Kansas Interscholastic Athletic Administrators Association (KIAAA), represented by Penny Lane, Washburn Rural; Matt Johnson, Olathe South HS; Jason Menard, Douglass; and Angelo Giacalone, Shawnee Mission Northwest; met with the Executive Board to present recommendations resulting from the KIAAA Annual Conference in March.

All recommendations were tabled until the June Executive Board meeting for final action. A list of the KIAAA proposal items follows:

#### Proposal #1

#### Basketball/Baseball/Softball

Should the KSHSAA change the state basketball, softball, and baseball brackets format for Classes 4A, 5A and 6A to an east/west cross bracket matchups for the first round of the 8-team state tournament?

#### Rationale:

#### Football (1A, 8P-DI, 8P-DII)

Should the KSHSAAchange their policy/practice/procedure of postseason football alignment for 1A, 8-Player Division I, and 8-Player Division II?

#### Rationale:

Proposed Change: The new playoff format would place teams into first round pools of four (resembling the 3-2-1A State Wrestling format). The first-round pools would feature a #1, #2, #3, and #4 seed from four different districts. For example, District 5 #1 would host District 6 #4 and District 7 #2 would host District 8 #3. This format will bring new cross-district matchups into the second round of the playoffs and push any potential district rematches back to the third round (Sectionals).

#### Bowling (Unified)

Should the KSHSAA adopt Unified Sports Bowling as a fully endorsed KSHSAA sport, consistent with KSHSAA/ NFHS rules regarding Unified sports?

President Alan Stein informed members should they wish to add an item to the agenda it could be done provided three-fourths of those present agreed. By a vote of 70-1, the Board approved adding the May 1, 2020 addendum items A-D to the agenda as items 12.A-12.D. By a vote of 62-9, the Board approved adding the May 1, 2020 addendum items E-F to the agenda as items 12.E and 12.F.

Motion by Kastle, second by Lewis, to approve the Minutes of the meeting conducted September 18, 2019. The vote was 69 in favor, 2 opposed. Motion passed.

# TENNIS CLASSIFICATIONS TO BE ASSIGNED FOR CALENDAR YEAR

A motion was made by Hubbard, seconded by Vanek, to modify Rule 5 Classification of Senior High Schools, Section 2, Article 1 by adding the following exception:

**Exception:** Classifications, for the purpose of determining boys and girls tennis assignments, shall be based on the total enrollment as submitted to the KSHSAA on the date established by state statute for official enrollment and will be for the two tennis seasons (boys and girls) in the calendar year following the classification.

The proposal was approved by a vote of 67 in favor, 4 opposed.

# LANGUAGE UPDATED FOR ELECTRONIC NICOTINE DELIVERY DEVICES

Motion by Lewis, seconded by Perkins, to modify Rule 14 Bona Fide Student, Section 1, Article 3 to include the following language:

**Art. 3:** A student who uses any form of tobacco, <u>Electronic</u> <u>Nicotine Delivery System (\*ENDS) devices</u>, illegal drugs,

alcoholic beverages, etc., at school events is not in good standing.

\*Note: ENDS is defined to be any device that delivers a vaporized solution (including nicotine, THC or any other substance) by means of cartridges or other chemical delivery systems. This includes, but may not be limited to, any electronic cigarette, vape pen, hookah pen, cigar, cigarillo, pipe, or personal vaporizer.

The proposal was approved by a vote of 71 in favor, none opposed.

# NON-VARSITY LEVEL FOR TRANSFERS FROM NON-MEMBER SCHOOLS

Motion by Graber, seconded by Renk, to modify Rule 18 Transfer, Section 1, Article 4 as follows:

Art. 4: TRANSFER FROM NON-MEMBER SCHOOL—Students who transfer from a school which is not a member of the KSHSAA or an Association of any state as recognized by the National Federation of State Associations, may be declared eligible at the non-varsity level by the Executive Board. (Process Form T-E T-E/P—Send a copy of it and a letter of request for eligibility to KSHSAA, identifying the non-member school.)

The proposal was approved by a vote of 63 in favor, 8 opposed.

#### TENNIS RULE UPDATED

A motion was made by McCormick, seconded by Morrisey, to modify **Rule 41 Tennis, Section 2, Article 5(c)** to read as follows:

- **Art. 5:** No student representing a member school shall participate in more than eight days of interschool competition during a season, exclusive of regional, sub-state and state tournaments.
  - a. Two dual meets may be substituted for one day of tournament competition provided no loss of instructional time would take place for competition and/or travel.
  - b. Schools are encouraged to schedule as many quadrangular or smaller events as possible. It is recommended these events start after school hours.
  - c. On those days when school time is used, only two four matches or tournaments may start prior to 3 p.m. C.T.

The proposal was approved by a vote of 65 in favor, 6 opposed.

# SPIRIT COMPETITION LANGUAGE UPDATED

A motion was made by Rosenhagen, seconded by Lewis, to update Rule 48 Spirit and Spirit Competition Groups, Section 1, Article 6(a) as follows:

a. Spirit competition groups attending in-state festivals, workshops or clinics during the school year may be rated and receive oral and/or written critiques, but shall not be ranked.

Exception: Participating school teams may be ranked in KSHSAA designated statewide event for respective spirit activities.

The proposal was approved by a vote of 69 in favor, 2 opposed.

# COVID-19 RESPONSE RECOMMENDATIONS APPROVED

In response to the COVID-19 impact on school activities, the Executive Board maintained a continual review process to provide additional items for the Board of Directors. These items are designed to modify existing rules in an effort to mitigate some negative aspects arising from this public health issue and the eventual resumption of interscholastic activities. As mentioned previously in the minutes, all items were approved to be included on the agenda for tonight's meeting. The recommendations and Board of Director votes for the items are below. Each item is for the 2020-21 school year only.

Motion by Reed, seconded by Lane, to approve items A through D as recommended.

#### A. Rule 7 - Physical Examination Parental Consent

**Recommendation:** No Recommendation. With a recommendation from the Kansas SMAC to maintain current system and continue to monitor the situation, there is no recommendation for change to the required PPE to be conducted after May 1, 2020, for all athletic participants per Rule 7-1-1. This item will be re-evaluated in the first week of June.

#### B. Rule 18 - Transfer

**Recommendation:** No Recommendation. Maintain the planned implementation date for the transition from 18 weeks to one year as designated by BOD adoption (Sept. 2019). Note: this rule change is for High School only.

#### C. Rule 9 - Moratorium

**Recommendation:** Suspend for Summer 2020. No matter when "summer" begins (no earlier than June 1), we propose the rule change to modify the summer moratorium rule by suspending the restrictions detailed in Rule 9-1-5 for the summer of 2020.

**D. Rule 10 and Rule 30** (combined for action as both deal with coach and athlete restrictions)

Rule 10-Qualifications of Coaches (Athletic, Spirit, Scholars Bowl, Debate and Speech) and Music Directors

**Recommendation:** Set aside relevant components of Rule 10, Section 1, Article 6 and 8 restricting football, volleyball, and basketball coaches/coaches' aides to restrictions detailed below.

Rule 30 - Seasons of Activities

**Recommendation:** Set aside relevant components of Rule 30, Section 1, Article 6 and 7 restricting student/coach contact to restrictions detailed below.

#### Recommendation for Summer 2020 Guidelines

When permitted by your community's local health authorities AND your school district administration, while following all group gathering restrictions and social distancing expectations, school employed coaches may begin their summer programs with their prospective student participants no earlier than June 1. As always, participation by a student in the summer program is voluntary. Similarly, schools may choose what, when, and how often programs are available to their students. The following conditions apply for any summer activity taking place in a school facility and/or under the guidance of a school employee:

- 1. The first calendar week (minimum five days of conditioning) of a summer activity program for any sport are limited to a maximum of three hours of physical activity per student per day. Physical activity includes any warm-up, stretching, conditioning and weight-lifting activities. Organized competition sanctioned by an outside organization or between students from different schools shall not take place during this time.
- 2. Beginning the second calendar week (minimum five days of conditioning) of a summer activity program, cumulative physical activity time as defined in #1 should not exceed five hours per student per day. Organized competition sanctioned by an outside organization or between students from different schools shall not take place during this time.
- 3. Students may begin organized competition under the guidance of their school coaches beginning the third week of a summer activity program.
- 4. One-week school coach team camps may begin after the ten-day acclimatization period detailed in 1 and 2 above and take place through August 15.
- Traditional fall school practices begin, and Handbook restrictions resume, on August 17, 2020.

#### $*Additional\ Recommendations\ for\ basketball$

 Basketball coaches may not hold team camp or work with their players between August 3 and August 16 as that time is dedicated to final fall season preparations.

#### \*\*Additional Recommendations for Football

- 7. Football must complete three calendar weeks of conditioning (minimum 15 days of conditioning)
  - a. During the first week, focus on strength and conditioning; limited individual football specific drills are allowed
  - b. During the second week, strength and conditioning continues; football related non-contact drills are permitted
  - c. During the third week, strength and conditioning continues; football related drills permitted; intrasquad 7-on-7 or 5-on-5 permitted; one-week coaches camp permitted (helmet only)

- 8. Following conditioning period defined in number 7 and through August 3, the following may be conducted:
  - a. Coaches working with their athletes in football related activities
  - b. 7 on 7 competitions
  - c. 5 on 5 competitions
  - d. Coaches one-week team camp (helmet only)
  - e. Strength and conditioning continues
- 9. From August 3 through August 15, the following may be conducted:
  - a. Coaches working with their athletes in football related activities
  - b. Coaches one-week team camp (helmet only)
  - c. Strength and conditioning continues
- 10.One team vs team camp, including college contact camp, is permitted for this summer; must be conducted by third party; maximum of two days; may be conducted any time after the 15 day conditioning period until August 15

These recommendations are based upon an anticipated practice start date of August 17 for fall sports; if there is a delay in the start, the calendar of recommendations may be modified.

The recommendations for items A through D were approved by a vote of 48 in favor, 23 opposed.

Motion by Herman, seconded by Briggs, to approve item E as recommended.

#### E. Scholarship Rule 13

Due to the Covid-19 pandemic students are at an academic disadvantage. Virtual learning and academic growth has been inhibited due to lack of computer hardware, poor bandwidth, absence of home supervision, and students having to take care of younger siblings.

Per KSHSAA policy, current 6th and 8th graders will have immediate academic eligibility for the fall semester of the 2020-21 school year. Current seventh graders will not have this same opportunity. The Covid-19 pandemic has prevented some of these students from reaching their academic potential and should not be withheld from KSHSAA activities for something that is beyond their control.

Note: At least one neighboring activity association granted relief of the academic standards for the fall semester of 2020-21 due to the unprecedented challenges that students have experienced.

**Recommendation** - Kansas school districts shall be granted local control to determine the academic eligibility standards for 7th grade students who will participate in activities at the beginning of the 2020-21 school year by setting aside **Rule 13 Scholarship Requirements Section 1, Article 3(a) and Section 3, Article 1(a)** for first quarter/semester only of the 2020-21 school year.

The recommendation for item E was approved by a vote of 51 in favor, 20 opposed.

Motion by Seyfort, seconded by Thon, to approve an amended item F as follows:

F. Recommendation - Kansas school districts shall be granted local control to determine the academic eligibility standards for 7th, 10th, 11th, & 12th grade students who will participate in activities at the beginning of the 2020-21 school year. This allowance would be a one semester district determination for participation during the Fall Semester of 2020.

The amended recommendation for item F was approved by a vote of 52 in favor, 19 opposed.
