BOARD OF DIRECTORS MEETING FORMAT

The Board of Directors assembled via virtual platform at 4 p.m. Friday evening for hearings, discussion, and final action on agenda items and Executive Board elections.

President Alan Stein informed members should they wish to add an item to the agenda it could be done provided three-fourths of those present agreed (52 votes would be required of 69 in attendance).

Following public hearings, discussion and final actions on all agenda items, the Board adjourned at 6:00 p.m.

EXECUTIVE DIRECTOR'S REPORT

Bill Faflick, Executive Director, called roll, presented remarks on the Association's financial position, and updated the members of the Board of Directors on business and policy matters of the Association.

PREVIOUS MINUTES APPROVED

Motion by Perkins, second by Kastle, to approve the Minutes of the meetings conducted September 16, 2020; November 24, 2020; December 8, 2020; and January 20, 2021. The vote was 69 in favor, 0 opposed. Motion passed.

All agenda items approved become effective immediately upon publication of these minutes unless otherwise specified. Abstentions from voting by Board of Director members count as an opposed vote.

NOTE: Words or phrases which appear underlined in the following sections indicate the changes which were made.

CLASSIFICATION AMENDMENT TIMELINE MODIFIED

A motion was made by Kastle, seconded by Schneeberger, to modify **Rule 5 Classification of Senior High Schools Section 1**, by adding the following **Article 1**:

Art. 1: Amendments to general classification shall not be subject to revision for the first three school years following initial application.

The proposal was approved by a vote of 64 in favor, 5 opposed. Note, as classification issues are subject to **Bylaw XII Classification of Senior High Schools**, this item will be forwarded to the Kansas State Board of Education for final determination.

SIXTH GRADE FOOTBALL PARTICIPATION AMENDMENT WITHDRAWN

The Western Kansas Liberty League asked the Board of Directors to modify **Rule 8 Middle/Junior High School, (7th, 8th and/or 9th) Participation in Interscholastic Activities, Section 3, Article 2** by removing the following language:

Art. 2: Middle/junior high (seventh and eighth grade) schools may permit sixth-grade students of the same school system or of an elementary school which lies wholly within an organized middle/junior high school district, to participate in middle/junior high activities other than **tackle football**, boxing and wrestling. Such participation will not adversely affect the eligibility of such students when they become middle/junior high school students.

NOTE: Sixth-grade students shall be subject to the Kansas State Board of Education regulations.

Principal Todd Flinn, Grainfield-Wheatland High School and WKLL representative, asked to withdraw the agenda item from consideration. He provided information to the Board on continuing league efforts to research the modification among schools. Subsequently, this item died for lack of motion and the Board took no action on the item.

ELIGIBILITY FOR MIDDLE SCHOOL/JUNIOR HIGH CLARIFIED

A motion was made by Perkins, seconded by Kastle, to modify **Rule 16 Semester Requirements, Section 1, Article 1** by adding the following language:

Art. 1: Once the school determines that a student is promoted from sixth grade, middle school/junior high eligibility begins immediately in the following semester. A student shall not have more than two semesters (the initial year of attendance) of possible eligibility in grade seven and two semesters in grade eight. Once the school determines that a student is promoted from eighth grade, high school eligibility begins immediately in the following semester. A student shall not have more than eight consecutive semesters of possible eligibility in grades nine through twelve, regardless of whether the ninth grade is included in junior high or in a senior high school.

NOTE: If a student does not participate or is ineligible due to transfer, scholarship, etc., the semester(s) during that period shall be counted toward the total number of semesters possible. (See Rule 30-1-1, Seasons of Activities.)

The proposal was approved by a vote of 66 in favor, 4 opposed.

TRACK AND FIELD LANGUAGE UPDATED

A motion was made by Horst, seconded by Marlin, to modify **Rule 42 Track & Field, Section 3, Article 3** by updating the following language:

Art. 3: The recommended order of events in invitational meets will be listed in the March issue of the KSHSAA Activities Journal provided by staff and based upon NFHS T&F Rules.

The proposal was approved by a vote of 69 in favor, none opposed.

UNIFIED BOWLING COMPETITION APPROVED

A motion was made by Rosenhagen, seconded by Perkins, to modify **Rule 45 Bowling (Girls & Boys)** by creating **Section 4** and the accompanying Articles:

Section 4: Unified Activity Regulations (apply to grades 9-12)

- **Art. 1:** Schools are encouraged to schedule as many dual matches as possible. It is recommended these competitions begin after school hours.
- Art. 2: Practice shall not begin prior to Monday of Standardized Calendar Week #13 of each calendar year.
- Art. 3: Competition shall not begin prior to Monday of Standardized Calendar Week #15.
- Art. 4: When needed, Regional Qualifying Tournaments shall be held during Standardized Calendar Week #19.
- Art. 5: The state tournament shall be held during Standardized Calendar Week #20.
- **Art. 6:** No student representing a member school shall participate in more than 4 days of competition during a season, exclusive of regional and state tournaments.

The proposal was approved by a vote of 60 in favor, 8 opposed.

SHOW CHOIR ACTIVITIES APPROVED FOR RANKING

A motion was made by Phillips, seconded by Harrell, to modify **Rule 46 Music, Section 1, Article 2(a)** as follows:

- **Art. 2:** Kansas music activities hosted by member schools or approved by the Executive Board may be rated and receive oral and/or written critiques but shall not be ranked or receive cash or merchandise awards.
 - a. Kansas marching band and show choir activities hosted by member schools or approved by the Executive Board may be ranked, rated and receive oral and/or written critiques as long as the event falls within the guidelines of the KSHSAA mileage limitations. Out-of-state music activities approved by the Executive Board and the out-of-state high school association may be ranked, rated and receive oral and/or written critiques as long as the activity falls within the guidelines of the KSHSAA mileage limitations. (See Bylaws, Article XIV Approval of Events.)

The proposal was approved by a vote of 66 in favor, 0 opposed.

COVID-19 MANDATORY FACE-COVERING END DATE APPROVED

The KSHSAA Board of Directors considered an update on action approved during the November 24, 2020 special meeting which approved the following by a vote of 76-1:

All participants (including but not limited to athletes, coaches, officials, spectators, support staff and all others attending/participating in school activities) shall wear a face covering in the manner it is intended to be worn (for purpose of COVID-19 risk mitigation) while at the event venue and for duration of the event. The only exception is provided for athletes during the time they are competing and for officials during active play.

Note of clarification for spring outdoor activities:

KSHSAA Executive Board interpretation (March 23, 2021): Any participant (including but not limited to athletes, coaches, officials, spectators, support staff and all others attending/participating in school activities) outdoors, who is able to maintain a minimum of six feet of social distancing would not be required to wear a face covering. Adherence to a more restrictive local health authority or school district policy is supported and expected.

Following the introduction of this issue, there was a motion by Marlin, seconded by Kastle, to amend the adopted language as follows:

The requirement for wearing a face covering terminates with the conclusion of KSHSAA spring championship activities for the 2020-21 school year. After the final KSHSAA spring championship, schools shall continue to adhere to all local risk mitigation policies. The KSHSAA strongly recommends face coverings continue to be worn until the CDC and KDHE indicate this health preservation measure is no longer necessary.

Following discussion, a motion was made by Shaffer, seconded by Schenk, to amend the proposed language as follows:

The requirement for wearing a face covering terminates on May 1, 2021 for all outdoor activities. The mask mandates for indoor activities will end at the end of the spring championships. Schools shall continue to adhere to all local risk mitigation policies.

The modified language recommendation was approved by a vote of 57 in favor, 12 opposed.
