The Executive Board met in the office of the Kansas State High School Activities Association on Wednesday and Thursday, June 16-17, 2021, with the following in attendance: President Alan Stein, Shannon Haydock, Jason Herman, Deena Horst, Mike Kastle, Monty Marlin, Roger Perkins, Greg Rosenhagen, Ken Stonebraker and Bill Faflick, Executive Director. Assistant Executive Directors Cheryl Gleason, Francine Martin, Mark Lentz, Jeremy Holaday, Craig Manteuffel, Rod Garman, Assistant Executive Director-Elect Annie Diederich, and Office/Operations Manager Brent Unruh. Jason Herman was unable to attend on June 17.

NOTE: Per **Bylaw Article V, Sec. 4**, new Executive Board members elected at the April Board of Directors meeting shall attend the June Executive Board meeting as observers and for orientation. Tim Bumgarner, Matt Garber, Tammie Romstad, Catherine Smith, Drew Thon and Linda Wiley were present as new members observing the meeting. President Alan Stein and President-Elect Roger Perkins participated with Mr. Faflick and staff in an orientation session with the Executive Board-elect members.

CONSENT AGENDA ITEMS

The following items were all approved unanimously via consent:

- Minutes of the April 29-30, 2021 Executive Board meeting.
- Minutes of the April 30, 2021 newly elected Executive Board meeting (following the conclusion of the Board of Directors meeting).
- Items approved by KSHSAA staff on behalf of the Executive Board. *(A list of these items may be found at the end of these minutes.)*
- A budget hearing was authorized to be held on September 15, 2021 at 11:30 a.m. in the KSHSAA Office. The Association budget for the 2021-22 school year will be finalized at that time. Interested parties are welcome to attend.
- To ensure the KSHSAA remains in compliance with the Kansas Open Records Law, the Executive Board voted to designate the Executive Director or his designee, as the "Freedom of Information Officer." Additionally, the Executive Director or his designee will serve as the "Custodian of the Records" for purposes of the Open Records Law.

PUBLIC FORUM

None present.

ADMINISTRATIVE REPORTS AND UPDATES

The Executive Board heard reports from the Executive Director and administrative staff regarding the status of programs and services of the Association. Staff reported key communications regarding general operations. The Executive Director provided a financial report, inclusive of available cash (checking), investments, and restricted funds.

HALL OF FAME COMMITTEE MEMBERS SELECTED

Steve Curran, retired A.D., coach, and Kansas Coaches Association officer from Girard, and Sue Givens, retired superintendent at El Dorado, were appointed to the Hall of Fame Selection Committee. They will replace Bob Jackson, Logan, and Tamie Preston, Dodge City, who have completed four-year terms on the committee. Marvin Estes, Wichita, was appointed to serve as chair of the committee for 2021-22.

AWARDS PROTOCOL REVIEWED

The Executive Board approved an update to policy and activity specific manuals to now include the following statement: "For regional/sub-state bracketed team sports, only classifications structured for full 8- team brackets (or larger) will receive runner-up team awards."

PUBLIC/PRIVATE DISCUSSION

The Executive Board reviewed a correspondence and received the work product developed by the Public/Private Work Group relating to concerns expressed regarding disparity of public member school postseason success compared to private member school postseason success. The work group proposed a multiplier model of classification for consideration which includes factors relative to school location, socio-economic status, and a championship factor. Following discussion, the Board voted to send the proposal to the Fall Regional Administrator and Board of Education meetings to be held in October for review and input from member schools.

EJECTION POLICY APPROVED

Continuing the discussion from the April meeting, the Executive Board discussed and approved the following policy for all inter-scholastic activities designed to enhance sportsmanship and to support adjudicators:

Any participant (player, coach, spectator) who is ejected for making contact with an official or who is ejected for unsporting behavior directed toward an official, shall be subject to a non-appealable suspension from the next contest at that level and for all contests at any level (in that activity) until the suspension has been served. Local school leadership may levy additional sanctions as they deem appropriate.

The KSHSAA staff reviews all ejection reports.

Note: the requirement for all ejected students to complete the NFHS Sportsmanship course and the requirement for all ejected coaches to complete the NFHS Teaching and Modeling Behavior course prior to being reinstated remain in effect.

SAND GREEN GOLF

Staff provided a review of Sand Green Golf participation this postseason and recent participation trends in this activity. The Executive Board approved the continuation of Sand Green Golf for one more year of competition and will assess participation during the spring 2022 season. Following the conclusion of next season and a review of options schools may exercise to maintain golf opportunities for students, a determination will be made regarding the continuing status of this activity.

The Executive Board determined ten medals will be awarded to top Sand Greens individuals and a team championship trophy will be awarded. Runner up team awards will not be provided.

VOLLEYBALL MANUAL

This past year, as one of the risk mitigation protocols implemented to combat the impact of COVID-19, teams maintained the same bench throughout a respective match for volleyball contests. This protocol was well received and followed unless an advantage/hardship was identified for maintaining one bench throughout a match. The Executive Board approved continued implementation of this protocol for the next season and will consider a more permanent amendment based upon input received from stakeholder groups following this next school year.

6-PLAYER FOOTBALL

In advance of the next cycle of football classification, staff provided an update on the status of 6-player school participation and anticipated next steps for football championships for 6-player, 8-player, and the 1A classification. The Executive Board approved an agenda item for the Fall Board of Directors meeting to consider 6-player championships (available for schools with 55 or fewer 9th-11th grade students on count day) contingent upon 24 or more schools indicating they will participate in 6-player competition for the 2022-24 cycle. Additionally, the agenda item will include consideration for the continuation of 2 divisions of 8-player until the number of participating 8-player teams is less than 64.

2021-2022 KSHSAA TENNIS MANUAL LANGUAGE

The Executive Board approved the adoption of the following language to be included in the Tennis Manual which further details the formation and work of the Arbitration Committee:

Arbitration Committee

The object of the **arbitration committee** is to obtain a fair resolution of disputes by an impartial third party without unnecessary expense or delay. They serve to review and interpret playing rules and policy situations that might occur during the event.

1. Regional Tournament - Two tennis coaches will be appointed by the tournament manager to serve with the tournament manager on the arbitration committee.
2. State Tournament - Four tennis coaches (1 per regional tournament) will be appointed by the tournament manager to serve with the tournament manager. The state official will also serve on the arbitration committee.
3. Any questions outside the responsibilities of the manager will be referred to the committee through the tournament manager.

4. The arbitration committee will only meet at the direction of the tournament manager.
5. Should any committee members have a player involved in a decision, that member should not participate in making the decision.
6. Members on the arbitration committee must remain onsite until the tournament has concluded.

CROSS COUNTRY AND TRACK & FIELD UNIFORM RULE

Based upon staff recommendation, the Executive Board approved amendments to the Legal Uniform Guide utilized for administration of cross country and track & field events. Specifically, cross country runners choosing to wear gloves are not required to match color of teammates gloves. Additionally, the definition of hair control devices and adornments was clarified for both cross country and track & field. Hair control devices are items that go around hair only. They must be a single solid color, but all teammates do not have to wear the same color.

SOCCER RULE CHANGE HEADS TO BOARD OF DIRECTORS

The Executive Board approved the proposed Handbook updates to be placed on the September Board of Directors Agenda impacting Soccer Rule 38 as noted:

Rule 38, Soccer, Section 1, Article 2

Art. 2: No member school shall participate in a **boys soccer** contest until it has had (9) nine days of team practice, prior to and not including the first scheduled day of competition. (*See Rule 30-1-8a-e, Seasons of Activities*).

- a. Each athlete shall participate in (9) nine days of practice with the team prior to participating in a **boys soccer** contest.

EXCEPTION: Girls participating in the state basketball tournament may participate with fewer than 9 days of practice.

SPIRIT ADVISORY COMMITTEE APPROVED

The Executive Board unanimously agreed for staff to continue pursuing the addition of a Spirit Advisory Committee for the 2021-22 school year. The Advisory Committee will geographically and demographically represent the state and will provide perspective for staff on important issues in advance of finalizing spirit activity determinations.

BASKETBALL SHOT CLOCK UPDATE

Staff provided clarification on the status of the option of adopting the shot clock. Due to an NFHS Rule amendment, the use of a shot clock is subject to state adoption starting in the 2022-23 school year. The Executive Board confirmed discussion on the shot clock is appropriate for the October Regional Administrator/BOE meetings. With input from those meetings, the Executive Board will make a determination in the spring of 2022 regarding possible adoption of the shot clock for Kansas interscholastic basketball games.

KANSAS COACHING SCHOOL

With the temporary suspension of Kansas Coaching School extended through this summer, staff shared plans for possible revisions to the format of Coaching School when it resumes August 1-2, 2022. The Executive Board provided suggestions for consideration for planning intended to enhance the experience for participating school coaches.

STAFF HANDBOOK UPDATES

Following a review, the Executive Board approved updates to the KSHSAA staff handbook to allow for changes in staffing that were made in the previous year.

MARKETING PROPOSAL

Recently, the KSHSAA staff has met with representatives of local and national marketing entities. Those firms have proposed marketing partnerships with the KSHSAA in order to provide a focus on student participants in Association activities and to generate resources in support of Association goals. Staff reviewed the highlights of these discussions and possible partnership.

ADVISORY GROUP RECOMMENDATIONS

Each year, the Kansas Association of Scholar's Bowl Coaches (KASBC), the Kansas Coaches Association (KCA), the Kansas Interscholastic Athletic Administrators Association (KIAAA), the Kansas Music Educators Association (KMEA), and the Kansas Speech Communications Association (KSCA), survey their membership and develop proposals. These recommendations are tabled and published in the April Executive Board meeting minutes to allow member schools to discuss them and provide feedback. Final discussion and action on all recommendations is undertaken in the June meeting by the Executive Board.

Recommendations Adopted

The following recommendations, submitted by various advisory groups were approved by the Executive Board:

Golf

1. **(Girls and Boys)** Use Max Score for golfers at regional and state tournaments. **(KCA)**

Rationale:

- *Allow a golfer to have the option to take a maximum score 12 on a hole. This would eliminate them from medal consideration but would allow the score to count toward their team score. The intent of this rule is twofold. To speed up play at post season events and also not embarrass golfers who are relatively new to the sport so hopefully they won't quit and have them continue to participate in golf at school. The data shows a golfer who scores 10+ on a hole does not typically contend for medals and team scores are not typically in the top 50% of team scores.*

2. **(Girls and Boys)** Eliminate the restriction of coaching on the tee box. **(KCA)**

Rationale:

- *The reasoning is because the tee box can be a very critical time to "coach" a player. Coaches would like to have the opportunity to talk through a player's first shot on each hole just like any other shot on the course while standing with the player so that the coach can point out certain strategies for the hole.*

Tennis

- 3. **(Girls and Boys)** Change the Regional Play-in matches seeding format. **(KCA)**

Rationale:

- Currently the play-in matches feed into Matches C and F or into the #5 and #6 seeds. The play-in matches usually are non-seeded (drawn-in) entries after the top seeds have been secured. It makes sense that the play-in matches feed into the #1 and #2 seeds, which are Matches A and H.

Rationale:

- *Would provide an opportunity for more student athletes to compete at the state meet.*

5. **(Girls and Boys)** Gloves, stocking caps, and headbands do not need to be the same color when used in inclement weather. **(KCA)**

Rationale:

- *There is no impact on performance or advantage gained by having gloves, stocking caps, and headbands that are the same color.*

Softball

7. Should the KSHSAA change the policy and procedures for postseason to be inclusive of the 15th-16th-17th and 18th seeds for softball as it pertains to Classes 4A, 5A and 6A? **(KCA)**

Rationale:

Tennis

8. **(Girls and Boys)** Change State Seeding Procedure to Seed the top 14, the remaining 10 entries would systematically be drawn in. The bracket on the next slide shows the shaded seeded numbers for the to 14 seeds. **(KCA)**

Rationale:

- *In the current seeding procedure only the 4 regional champions are in the conversation for seeding at State. The runners-up along with all 3rd-6th place finishers at each regional meet are never considered for seeding at State. Only the 4 regional champions are seeded at the State under the current seeding procedure.*

Volleyball

9. Use Max Preps ranking system for postseason play for all classes. **(KCA)**

Rationale:

- *The Max Preps ranking system will take into account: win/loss percentage, opponents win/loss percentage, head to head results, quality of win, and strength of schedule.*

10. Change the Sub-State format for 6A, 5A, & 4A. **(KCA)**

Rationale:

- *The state tournament will be a representation of the top teams in the state.*

11. Change the Sub-State format for 3A & 2A. **(KCA)**

Rationale:

- *The state tournament will be a representation of the top teams in the state.*

12. Change the Sub-State format for 1A DI and 1A DII. **(KCA)**

Rationale:

- *The state tournament will be a representation of the top teams in the state.*

Wrestling

13. (Girls and Boys) The certification process be changed to: (KCA)

1. Alpha weigh-in prior to the first practice (including hydration test).
2. 8% weight loss still in place (doctor sign off if an athlete chooses to lose more than 8%)
3. 50% of weigh-ins must be at the lowest weight class athlete will wrestle at the Regional tournament.
4. 2 lb. growth allowance granted at the first competition following Christmas.
5. Initial certification must be completed at a competition weigh-in prior to Christmas break. (Scratch weight no hydration test.)
6. Recertification may be done at a lower weight class after Christmas break until a deadline of February 1st (scratch weight no hydration test) KSHSAA permission not needed for recertification.
7. Written exceptions for late certification could be granted by KSHSAA in special circumstances. (Injured athlete that competes for the first time after February 1st deadline.)

Rationale:

- *Most athletic directors do not want to do hydration determination on athletes from other schools. With shoulder-to-shoulder weigh-ins, the need for this second hydration assessment is not needed as most athletes are not cutting near the weight now.*

No Action Items

The Executive Board took no action on the following items, because it is existing policy or because no action is necessary.

Cross Country

1. **(Girls and Boys)** Hair ribbons and hair bands do not need be the same color. **(KCA)**

Rationale:

- *There is no impact on performance gained by having hair place holders that are the same color.*

2. Use the following order of play for the state tournament. **(KCA)**

Wrestling

3. **(Boys)** The KWCA proposes the following fourteen boys wrestling weight classes: 106, 113, 120, 126, 132, 138, 144, 150, 157, 165, 175, 190, 215, 285. These 14 weights are based on Optimum Performance Calculator data collected and analyzed from the 41 states that use the system. **(KCA)**

Rationale:

- *The weight classes would more evenly distribute the number of athletes competing in each weight class. The proposed weight classes were determined by the analysis of weigh-in data from 41 states that use the OPC system.*
