The Executive Board met in the office of the Kansas State High School Activities Association on Wednesday and Thursday, June 15-16, 2022, with the following in attendance: President Roger Perkins, Justin Briggs, Deena Horst, Mike Kastle, Tammie Romstad, Justin Seuser, Sean Spoons, Delvin Strecker, Drew Thon, Paul Zuzelski and Bill Faflick, Executive Director. Assistant Executive Directors Francine Martin, Mark Lentz, Jeremy Holaday, Craig Manteuffel, Rod Garman, Annie Diederich, Kyle Doperalski, Sarah Smith, Director of Operations Brent Unruh and Director of Officials Scott Goodheart. Board members David Abel and Ben Mitchell were unable to attend.

NOTE: Per **Bylaw Article V, Sec. 4**, new Executive Board members elected at the April Board of Directors meeting, shall attend the June Executive Board meeting as observers and for orientation. Kellen Adams, Rick Byers, Alan Penrose, Travis Powell, Casey Seyfert and Linda Wiley were present as new members observing the meeting. President Roger Perkins and President-Elect Drew Thon participated with Mr. Faflick in an orientation session with the Executive Board-elect members.

CONSENT AGENDA ITEMS

The following items were all approved unanimously via consent:

- Minutes of the April 26-27, 2023, Executive Board meeting.
- Minutes of the April 27, 2023, newly elected Executive Board meeting (following the conclusion of the Board of Directors meeting).
- Items approved by KSHSAA staff on behalf of the Executive Board. (A list of these items may be found at the end of these minutes.)
- The Executive Board authorized a budget hearing to be held on Wednesday, September 13, 2023, at 11:30 a.m. in the office of the KSHSAA. The Association budget for the 2023-24 school year will be finalized at that time. Interested parties are welcome to attend.
- To ensure the KSHSAA remains in compliance with the Kansas Open Records Law, the Executive Board voted to designate the Executive Director or his designee, as the "Freedom of Information Officer." Additionally, the Executive Director or his designee will serve as the "Custodian of the Records" for purposes of the Open Records Law.

ADMINISTRATIVE REPORTS AND UPDATES

The Executive Board heard reports from the Executive Director and administrative staff regarding the status of programs and services of the Association. Staff reported key communications regarding general operations and spring activity championship events. The Executive Director provided a financial report and updates on Association business.

POLICY AND STATUTE ALIGNMENT FOR NON-PUBLIC SCHOOL STUDENTS

Based upon the inclusion of non-public school student eligibility in the state budget bill, multiple policy modifications are necessary immediately. Staff provided recommendations for the Executive Board which will allow member schools to adhere to new regulations passed by the state legislature at the beginning of May as detailed in House Sub for SB 113. These modifications alter some of the foundational elements of education-based activities by creating double standards for non-public school students compared to member school students. Discussion was held on current KSHSAA eligibility rules that could apply to those students who are not attending member public schools but wish to participate on a KSHSAA activity for that school and situations that may arise to challenge established rules that apply to currently enrolled member school students. Staff prepared an eligibility form for tracking these students and providing member schools with verification for application. The Board approved the presented form and policy information for distribution to all member schools.

HIGH SCHOOL ASSIGNED TO LEAGUE

Based on the action of the Executive Board at its' March 2023 meeting, Superintendent John Whetzal and other staff members from Wathena-Riverside High School appeared before the Executive Board seeking a league assignment for their school per **Bylaw ARTICLE XV, League Affiliation**. The Board granted this hearing based on repeated unsuccessful efforts by Riverside High School to secure a new league affiliation.

Following a presentation by the school, administrative representatives of the Big 7 and Northeast Kansas Leagues presented information regarding the status of their leagues and their position on the potential assignment of a new member school. The following administrators appeared on behalf of their respective leagues:

- Big 7 League** – Prin. Cassie Geis, Hoyt-Royal Valley; Ath. Dir. Brandan Giltner, Holton; Ath. Dir. David Schooler, Silver Lake.
- Northeast Kansas League** – Prin. Joe Worthington, Winchester-Jefferson County North; Supt. Brad Kempf, Winchester-Jefferson County North.

Following presentations, a question/answer period, and extensive discussion, the Executive Board approved assigning Wathena-Riverside High School to the Northeast Kansas League beginning with the 2024-25 school year.

All parties were reminded in accordance with KSHSAA **Bylaw ARTICLE XV, League Affiliation**, schools are not permitted to withdraw from a league to which a school has been assigned for a period of three years without a unanimous vote by all member schools of the league including the newly assigned member school. All schools were reminded existing game contracts shall be honored as they proceed to incorporate the newly assigned schools into their respective leagues.

HALL OF FAME COMMITTEE MEMBERS SELECTED

Lou Mignone, former teacher and veteran registered official from Winfield, and Jamelle Brown, former teacher, coach/sponsor, and NFHS committee member from Kansas City, were appointed to the Hall of Fame Selection Committee. They will replace Martha Gabel, Olathe, and Gerald Henderson, McPherson, who have completed four-year terms on the committee. Bill Lowry, Almena, was appointed to serve as chair of the committee for 2023-24.

BOARD OF DIRECTORS MEETING BREAKOUT DEBRIEF

As part of the April 27 Board of Directors meeting, respective classifications of schools conducted breakout sessions to discuss critical topics which may require action or further study, including placement on the Regional Administrator and Board of Education Meeting agenda. Board members discussed items brought up during these sessions, including baseball/softball game limits.

DISCUSSION ON SOCCER AND ANTI-TRYOUT RULES

Staff led a discussion relative to components of Rule 26, Anti-Tryout and Private Instruction, and conversations with those in the soccer community. A growing trend is for colleges to host "ID Camp" which are more evaluative in nature (little, if any instruction, takes place). The current Kansas dual seasons (boys/fall, girls/spring) are not in sync with postsecondary programs which host these camps for prospective students. No action was taken.

EXECUTIVE SESSION

At the request of the Executive Director, the Board entered an Executive Session to discuss matters related to non-elected personnel. Following this session, the Board approved recommendations for staff salaries

SPRING ACTIVITIES RECAP

Staff led discussion regarding the success and challenges with each of the recently completed spring culminating/championship events. The Executive Board members provided feedback and made suggestions for modification and future enhancements. The Board voted to approve changes to the soccer championship tournament game start times, beginning with the 2023-24 seasons. These changes are as follows:

CHAMPIONSHIP FORMATS

Following discussion at the April meeting, the Executive Board considered modified championship formats in the activities of football, soccer (both fall and spring), basketball and wrestling. It was approved to allow the staff to adjust the times for football and approve the new format as presented. For soccer, the postseason proposal was approved as presented by staff. In basketball, it was decided to send the format to the regional meetings held in October for further discussion by schools. The wrestling championship format time frame was approved as presented. *See Addendum.*

CHAMPIONSHIP TOURNAMENT SEEDING

Staff presented a draft of what the Executive Board should consider as they contemplate next steps in creating larger pools for the initial rounds of postseason basketball and volleyball in classes 1A-DI, 1A-DII, 2A, and 3A. As part of the discussion, staff also reviewed the postseason officials assignment process for basketball and volleyball. For both activities, staff were provided feedback and asked to amend the proposals which will be reviewed and ready for action at the September 2023 meeting which would include sending options to the October Regional Meetings for review. *See Addendum.*

2023-24 EXECUTIVE BOARD

Following a change in job opportunities, Sean Spoons resigned from his position on the 2023-24 Executive Board. While an election was held and a Class 3A representative was found in Beloit High School Principal Casey Seyfert, there was still a vacancy in the Secretary/Treasurer position on the Executive Board. After a call for nominations, Athletic Director Justin Briggs, Dodge City-Comanche Middle School, was appointed to serve as the Secretary/Treasurer for the 2023-24 school year.

ADVISORY GROUP RECOMMENDATIONS

Each year, the Kansas Association of Scholar’s Bowl Coaches (KASBC), the Kansas Coaches Association (KCA), the Kansas Interscholastic Athletic Administrators Association (KIAAA), the Kansas Music Educators Association (KMEA), and the Kansas Speech Communications Association (KSCA), survey their membership and develop proposals for amendments to rule and/or championship protocol. These recommendations were introduced at the April Executive Board meeting, captured and distributed via meeting minutes to allow member schools to discuss them and provide feedback. Final discussion and action on all recommendations was conducted at the June meeting of the Executive Board.

Recommendations Adopted

The following recommendations, submitted by various advisory groups were approved by the Executive Board for immediate implementation:

Tennis

1. Should the KSHSAA change the state tournament seeding procedure as follows: (KCA)
 - Seeds #1 – 12 will be determined as follows:
 - a. The 4 regional champions will be considered for the #1 seed. The seeding conversation for the #1 seed shall be limited to only the 4 regional champions.
 - b. Each time a player (or doubles team) is seeded, the next highest placing finisher from such player’s (or doubles team) regional meet moves into the seeding conversation. For example:
 - i. For this example, the 4 Regions are assigned letter designations - A, B, C, D.
 - ii. If Region C champion is seeded #1 in a singles or doubles draw, then
 - iii. Regions A, B, and D champions are still up for consideration to be the #2 seed, and Region C’s second place finisher is automatically added for consideration to be the #2 seed.
 - c. This process continues until seeds #1 – 12 are filled, with one exception. All regional champions (4 in singles and 4 in doubles) are guaranteed a seed within the top 12.
 - d. Only 4 players or doubles teams are involved in the seeding conversation at any time.

Rationale:

- *This allows for regional tournaments with state qualifiers depth to have an opportunity for seeding placement on the State Tournament bracket.*
- *Currently only the four regional champions are seeded in positions 1-4. The remaining 83% of the singles/doubles entries are never considered in state seeding discussions. Instead, they assume a slot on the State Tournament bracket based solely on the seeded position (1-4) of their regional champion.*

2. **(Classes 6A & 5A Only)** Should the KSHSAA eliminate the #17 & #18 seeds in EVERY sport from postseason brackets? (KIAAA)

Rationale:

Golf

1. Should the KSHSAA change Handbook **Rule 36, Golf (Girls & Boys), Article 3** to read: (KCA)

Art. 3: The state tournament

- Girls – Shall be held on Monday and Tuesday, insofar as possible, of Standardized Calendar Week #16. Regionals, when needed, will be held the previous week.
- Boys – Shall be held on Monday and Tuesday, insofar as possible, of Standardized Calendar Week #47. Regionals, when needed, will be held the previous week.

2. Should the KSHSAA remove Handbook **Rule 36, Golf (Girls & Boys), Article 6: (KCA)**

Art. 6: ~~The Executive Board may schedule summer tournaments, if a sufficient number of schools enter summer competition.~~

- ~~A school shall not participate during the school year and in summer competition.~~
- ~~A school shall declare its choice in advance.~~

Rationale:

- Article 6 is obsolete

Items Referred To Fall Regional Administrators and Board of Education Meetings

The following recommendations, which were submitted by advisory groups as noted below, will be submitted for discussion and consideration by those attending the Fall Regional Administrators and Board of Education Meetings conducted in October 2023 at seven different sites across the state:

Basketball

1. **(Classes 6A & 5A Only)** Should the KSHSAA add a 30 second shot clock to all varsity basketball games in 5A and 6A (both boys and girls basketball)? (KIAAA)

Golf

3. Should KSHSAA allow 2 tournaments to start before 12 o'clock and the rest can start at 1:00? **(KCA)**

Rationale:

- *The 3:00 tournaments are almost always pushing darkness.*

Tennis

4. Should the KSHSAA change Handbook **Rule 41, Tennis (Girls & Boys), Section 2, Article 4** to read: **(KCA)**

Art. 4: No student representing a member school shall participate in more than eight days of interschool competition during a season, exclusive of regional, sub-state and state KSHSAA postseason tournaments.

- ~~Two dual meets may be substituted for one day of tournament competition provided no loss of instructional time would take place for competition and/or travel.~~
- Schools are encouraged to schedule as many quadrangular or smaller events as possible. It is recommended these events start after school hours.
- On those days when school time is used, only four matches or tournaments may start prior to 3 p.m. C.T.

Rationale:

- *Remove substate because it is not a level in tennis postseason play*
- *Most other sports/activities currently are leaving on school time to accommodate district transportation needs; lack of tennis courts lighting; letter "c" limits starting times.*

Volleyball

5. **(Class 3A Only)** Should the KSHSAA split the State into four groups of 16 and create two sub-states? **(KIAAA)**

Rationale:

Recommendations Denied

The Executive Board voted to deny the following recommendations, which were submitted by various advisory groups, etc.:

Golf

1. Should the KSHSAA change Handbook **Rule 36, Golf (Girls & Boys), Article 7** to read: **(KCA)**

Art. 7: No student representing a member school shall participate in more than eight days of interschool competitions during a season, exclusive of regional and state tournaments.

2. Should the KSHSAA change Handbook **Rule 36, Golf (Girls & Boys), Article 7(c)** to read: **(KCA)**

- ~~On those days when schooltime is used, only two matches or tournaments may start prior to 3 p.m. C.T. and four additional matches or tournaments may start no earlier than 1 p.m. C.T. The two remaining matches must begin no earlier than 3 p.m. C.T. On those days when school time is used, two meets/tournaments must start at 3 p.m. C.T. or later. Four meets/tournaments may start no earlier than 1 p.m. C.T. and the two remaining meets/tournaments may start any time.~~

Rationale:

- *Sometimes long golf runs into daylight issues*

3. **(Girls - Classes 6A & 5A Only)** Should the KSHSAA change their policy/practice or procedure of having three regional sites for 6A and 5A girls' golf to four regional sites like the boys? **(KIAAA)**

Rationale:

Tennis

4. Should the KSHSAA restructure classifications for regional tournament assignments by assigning four (4) regional tournaments with eight (8) schools each in 6A, 5A and 4A with the remaining schools in 3-2-1A, all based on official enrollment numbers to the KSHSAA. **(KCA)**

Rationale:

- This allows for balanced one day regional tournaments in classes 6A, 5A and 4A. Class 3-2-1A would be a one day tournament if there are 36 or fewer schools. Otherwise, a two day tournament will be needed.
- This facilitates the required minimum number of 24 schools with tennis necessary for a State Tournament.
- This will eliminate the 40%-60% split currently used for 4A and 3-2-1A.

Volleyball

5. Should KSHSAA allow players to touch the volleyballs 10 minutes prior to 20 minute warm up for postseason matches/play. **(KCA)**

Rationale:

- The current format only allows each team a 20 minute warm up.

GOLF MANUAL UPDATES

After a trial run at certain locations this past golf season, the Board voted to approve use of live scoring via cell phone in postseason play for golf. Also approved is an amended set of spectator guidelines for postseason golf. Note, the spectator guidelines are communicated through host managers and through school leadership (coach and administrator). Schools are encouraged to follow these guidelines for regular season competitions.

BASEBALL/SOFTBALL SEEDING AMENDMENTS

Following discussion, a change was made to the Baseball/Softball Manual to the seeding date and first rounds of playdates for the 3-2-1A baseball postseason effective with the spring 2024 season.

KANSAS COACHING SCHOOL

Staff provided an update on the Kansas Coaching School which is scheduled for July 31-August 1 in Topeka. A list of speakers was reviewed and plans for sessions was discussed.

LOSS OF INSTRUCTIONAL TIME SURVEY

Every four years, the KSHSAA conducts the Loss of Instructional Time Survey which is intended to reflect actual lost time for school students and teaching staff. The next survey is scheduled for the upcoming school year. Following discussion about the time spent on compiling data and the use of data by schools and outside agencies, the Board voted to suspend the survey for the 2023-24 cycle and reevaluate the need for this survey in four years.

2024 STATE WRESTLING TOURNAMENT CHANGE

Due to some scheduling issues, the 2024 state wrestling tournament held in Hays (FHSU) is being moved to Salina (Tony's Pizza Events Center). The KSHSAA completely understands the scheduling situation with Fort Hays State University, as they and the city of Hays have been and continue to be a great partner with the KSHSAA and our member schools.

With the venue change for 2024, the format for the 3-2-1A Boys, 4A Boys, and the 4-1A girls will be altered into a three-day tournament format. The tournament will be held on Thursday, February 22 – Saturday, February 24, 2024.

1. Changes include:

- a. 3 days of competition weigh-in for each division.
- b. 8 mats will be used for the competition on Thursday and Friday.
- c. 4 mats will be used on Saturday for all consolation semi-finals and medal matches.
- d. The schedule will be released later.
 - All wrestlers will wrestle two matches on Thursday.
 - The number of rounds on Friday will be determined later.

3-2-1A Basketball Post-Season Thoughts

- 2023-2024 will be exactly like 2022-2023 because contracts are out and officials are scheduled for regular season games in the last half of February
 - Many officials are working 4A-5A-6A regular season games as we extend the 1A-2A-3A post season earlier into February.
- The information below begins with the 2024-2025 school year
- KSHSAA assigns all officials – this can't begin until seeding takes place

How it will work – Option 1 and 2

- Each class will have four regions based on geography as assigned by the KSHSAA. Each region has 16 teams each. Each region has 16 teams each and will be established prior to the first date of competition.
- Each region in each class will have a Seeding Manager (BB-1, BB-2, trophies, balls, input seeding)
- The regions are seeded as such
 - Group A: 1, 4, 5, 8, 9, 12, 13, 16
 - Group B: 2, 3, 6, 7, 10, 11, 14, 15
 - The first thing that happens after groups are established is determining the host site for the sub-state semi-final and final. This will be the top seed in each group that can host (availability, capacity, no restraining lines). If the hosts for the semi-finals and finals happen to lose in the quarter finals, that school is still the host for the group, even if their team is eliminated.
 - If the number one and number two seed can't host, the opportunity to host the semi-finals and finals will go to the second highest seeded team, and so on until a host site is found. For instance, if the number one seed can't host, the opportunity will be given to the number four seed.
 - If no team can host, it is to be the top seed's responsibility to find a venue that can host and meet the requirements.
 - Sub-state quarter-finals are played at the higher seed. If the higher seed can't host, the game will be played at the lower seed. If the neither team can host, the game will be played at the host site of the semi-finals and finals.
