Wed 9/14 12. Executive Session – The Executive Director requests the opportunity to meet with the Executive Board to discuss personnel matters related to non-elected personnel.

- 13. **Board of Directors Meeting Agenda Preview** Staff will review the Board of Directors agenda and finalize introduction of items and topics to address in breakout sessions. Orientation topics will be provided for use during the breakout session. *–See Support Material–* (Information/Discussion)
- 14. **Regional Administrator Meetings** Staff will review topics identified for Regional Administrator meetings. Feedback from the regional meetings will be reviewed at the November Executive Board meeting with next steps on each item discussed and determined by the Executive Board at that time. –*See Support Material*–(Information/Discussion)
- 15. Transfer Rule 18 Foreign Students Per Handbook Rule 18-1-12, the Executive Board is charged with evaluation and approval consideration for agencies sponsoring foreign exchange students. Historically, this approval is based upon delegation of review by the CSIET. However, the Executive Board may consider additional programs for approval in unique circumstances. One program requesting approval consideration is *Children Around the World* who sponsors two Kansas students this year. Prior to this year, CATW has been an approved agency, and they plan to renew in future years. However, for this year, they were not approved due to lack of sponsorships during the Covid school years. –See Support Material– (Information/Discussion/Action)
- 16. Outside Competition Rule 22 With the second year of Unified Bowling, the Bowling Proprietors Association is requesting relief from the Outside Competition rule for partners participating in bowling. For the first year of Unified Bowling, a special exemption was provided for team members to participate in select tournaments while a member of the Unified school team. This was made possible by action of the Board of Directors during a special meeting of the Board on October 15, 2021. At this time, the Proprietors assert Unified Bowling is significantly different than interscholastic bowling and should not be considered a violation of Outside Competition Rule 22. Support materials include an exchange of correspondences between the KSHSAA and the Proprietors Association, as well as a roster of activities which have been approved for dual participation (while on a school team) and those activities which are considered the same activities and would be violations of the Outside Competition rule. –See Support Material– (Information/Discussion/Action)
- 17. **Review of Transfer Hardship Application** The KSHSAA has received a hardship application from a member school requesting eligibility for a spring activity. Staff will review circumstances around this transfer and receive Board input prior to final determination. –*See Support Material* (Information/Discussion/Action)

- 18. **Review of Eligibility** A member school has asked the KSHSAA to consider extenuating circumstances for a senior student who has been declared ineligible for the fall semester based upon actions during the spring of 2022. - 19. Inside Out Coaching Initiative The KSHSAA has been approached by the Inside Out Coaching leadership team including Joe Ehrmann and Jodi Redman. Under a sponsorship with the Kansas City Chiefs and the National Football League, coaches training would be free for all KSHSAA schools. Staff will provide an update on this opportunity. As the State Board meets at the same time the Executive Board is meeting, we will monitor their agenda and listen when the Classification item is being discussed.
