VIRTUAL MEETING of the KSHSAA BOARD of DIRECTORS

Friday, April 30, 2021 – 4:00 p.m.

(hearings, discussion, final action and Executive Board elections)

Bylaws, XVI, amendments, state:

- **Section 1:** The bylaws and articles of incorporation may be amended at any regular or called meeting of the Board of Directors by a majority vote of those present of the Board of Directors, and the approval of the Kansas State Board of Education.
- **Section 2:** KSHSAA Board of Directors' agenda items must be presented in writing to the Association Executive Director 40 days in advance of the September and April meetings. Only those items submitted by the following will be recognized:
 - 1. Board of Directors members
 - 2. Executive Board, provided the item received a majority vote of those present
 - 3. Superintendents, principals and board of education members of member schools
 - 4. Board of Directors may add items, which were not previously published on the agenda, at the time of the meeting, provided it is done by three-fourths vote of those present.

On page 22 of the *KSHSAA Handbook*, under **Rules and Regulations Governing Grades 7-12**, the first paragraph concerning AMENDMENTS reads as follows:

The rules and regulations for grades seven through twelve (grade school, middle school, junior high and senior high) may be amended at any regular or called meeting of the Board of Directors by a majority vote of those present.

In the 1981 legislative session, the following, which applies to unified school districts, was passed:

Any member who abstains from voting shall be counted as voting against the motion or resolution. If a member announces a conflict of interest with regard to the issue, the member may leave the meeting until the voting on the issue is concluded, and the member who abstains from voting thereby shall not be counted as having voted. K.S.A. 72-1138.

Comments shall not reference/identify personnel matters concerning Association or school employees and/or matters that would violate the privacy of students. When submitted, complete contact information (first/last name, city/state, daytime phone number) is necessary in order for the comments to be included in the addendum to the Executive Board minutes. Incomplete information will result in the comments not being shared nor included in the minutes.)
- 6. Approve September 16, 2020; November 24, 2020; December 8, 2020; and January 20, 2021 Minutes.

Introduction, Discussion and Vote will be held simultaneously on the following action items: (Unless otherwise indicated, underlined portions are recommended changes in rules.)

7. Modify Rule 5 Classification of Senior High Schools Section 1, by adding the following Article 1:

Art. 1: Amendments to general classification shall not be subject to revision for the first three school years following initial application.

8. Modify Rule 8 Middle/Junior High School, (7th, 8th and/or 9th) Participation in Interscholastic Activities, Section 3, Article 2 to remove the following language:

Art. 2: Middle/junior high (seventh and eighth grade) schools may permit sixth-grade students of the same school system or of an elementary school which lies wholly within an organized middle/junior high school district, to participate in middle/junior high activities other than tackle football, boxing and wrestling. Such participation will not adversely affect the eligibility of such students when they become middle/junior high school students.

NOTE: Sixth-grade students shall be subject to the Kansas State Board of Education regulations.

Referred by Western Kansas Liberty League (March 17, 2021)

- 9. Modify Rule 16 Semester Requirements, Section 1, Article 1 per the following:
 - Art. 1: Once the school determines that a student is promoted from sixth grade, middle school/junior high eligibility begins immediately in the following semester. A student shall not have more than two semesters (the initial year of attendance) of possible eligibility in grade seven and two semesters in grade eight. Once the school determines that a student is promoted from eighth grade, high school eligibility begins immediately in the following semester. A student shall not have more than eight consecutive semesters of possible eligibility in grades nine through twelve, regardless of whether the ninth grade is included in junior high or in a senior high school.

NOTE: If a student does not participate or is ineligible due to transfer, scholarship, etc., the semester(s) during that period shall be counted toward the total number of semesters possible. (*See Rule 30-1-1, Seasons of Activities*.)

- 10. Modify Rule 42 Track & Field, Section 3, Article 3 per the following:
 - Art. 3: The recommended order of events in invitational meets will be listed in the March issue of the KSHSAA Activities Journal provided by staff and based upon NFHS T&F Rules.

11. Modify Rule 45 Bowling (Girls & Boys) by creating Section 4 and the accompanying Articles:

Section 4: Unified Activity Regulations (apply to grades 9-12)

Art. 1: Schools are encouraged to schedule as many dual matches as possible. It is recommended these competitions begin after school hours.

Art. 2: Practice shall not begin prior to Monday of Standardized Calendar Week #13 of each calendar year.

Art. 3: Competition shall not begin prior to Monday of Standardized Calendar Week #15.

Art. 4: When needed, Regional Qualifying Tournaments shall be held during Standardized Calendar Week #19.

Art. 5: The state tournament shall be held during Standardized Calendar Week #20.

Art. 6: No student representing a member school shall participate in more than 4 days of competition during a season, exclusive of regional and state tournaments.

NOTE: Additional information regarding Unified Bowling is provided via supplemental support material.

12. Modify Rule 46 Music, Section 1, Article 2(a) as follows:

- **Art. 2:** Kansas music activities hosted by member schools or approved by the Executive Board may be rated and receive oral and/or written critiques but shall not be ranked or receive cash or merchandise awards.
 - a. Kansas marching band <u>and show choir</u> activities hosted by member schools or approved by the Executive Board may be ranked, rated and receive oral and/or written critiques as long as the event falls within the guidelines of the KSHSAA mileage limitations. Out-of-state music activities approved by the Executive Board and the out-of-state high school association may be ranked, rated and receive oral and/or written critiques as long as the activity falls within the guidelines of the KSHSAA mileage limitations. (*See Bylaws, Article XIV Approval of Events.*)

13. Establishing end date for mandatory face-covering in response to Covid-19:

At the special meeting of the KSHSAA Board of Directors on November 24, 2020, the following rule was approved by a vote of 76-1:

All participants (including but not limited to athletes, coaches, officials, spectators, support staff and all others attending/ participating in school activities) shall wear a face covering in the manner it is intended to be worn (for purpose of COVID-19 risk mitigation) while at the event venue and for duration of the event. The only exception is provided for athletes during the time they are competing and for officials during active play.

Note of clarification for spring outdoor activities:

KSHSAA Executive Board interpretation (March 23, 2021): Any participant (including but not limited to athletes, coaches, officials, spectators, support staff and all others attending/participating in school activities) **outdoors**, who is able to **maintain a minimum of six feet of social distancing** would not be required to wear a face covering. Adherence to a more restrictive local health authority or school district policy is supported and expected.

The Executive Board proposes the following update to the adopted language:

The requirement for wearing a face covering terminates with the conclusion of KSHSAA spring championship activities for the 2020-21 school year. After the final KSHSAA spring championship, schools shall continue to adhere to all local risk mitigation policies. The KSHSAA strongly recommends face coverings continue to be worn until the CDC and KDHE indicate this health preservation measure is no longer necessary.

14. Elect Executive Board Members from the Board of Directors per Bylaw Article V.

- **Sec. 2:** Board of Director members shall elect Executive Board members at their spring meeting in the categories listed, to two-year terms. A Director shall serve at least one year as a member of the Board of Directors prior to being elected to the Executive Board. Members in each category shall elect their own representative. Board of Directors organizational members are eligible for election in their school's respective category.
 - a. Classes 6A, 4A, 2A, in even years
 b. Classes 5A, 3A, 1A in odd years
 c. Middle/Junior High Schools in even years
 d. Board of Education in odd years
 e. State Board of Education in even years

Academics + Activities = Curriculum Partners WHY HAVE STUDENT ACTIVITIES? In the last few years the value of

high school activities has been questioned. Let's set the record straight as to what high school activities are all about. First of all, they are not a separate part of our overall education program but an integral part of it. A good, wellrounded education means not only one that is academically oriented, but one that also includes physical, social and emotional development. These are available through a good school activities program.

Activities are a citizenship laboratory-Participation in activities encompasses all races and creeds, and teaches a student that it is a privilege and an honor to represent his or her school. Students learn that activities are important because they show a person how to win, and how to lose. Activities teach self-confidence, poise, respect for the rules and good sportsmanship. Through participation in activities, students learn tolerance and understanding for people and how to control their emotions. They also learn the self-satisfaction of accomplishing a goal.

Interscholastic activities constitute a part of the right kind of "growing up" experiences for American boys and girls. Youth are interested in doing things well-in belonging-in displaying loyalty. With a well administered school program, students and spectators become better citizens through participation and observance of activities conducted under established rules impartially administered.

Activities encourage physical and mental excellence-Documented reports and statistics from the high schools of Kansas continue to show the "holding power" of activities programs. Those students engaged in any phase of the extracurricular program show a drop-out rate far below that of the uninvolved student. Over 90 percent of those students who drop out of school at the senior high level have never been involved in any activity as representatives of their school!

Grade point averages of students in athletics, speech, music, cheerleading, club programs, etc., rank well above those students who choose not to participate. Interestingly enough, the statistics point out "the more participation the better the GPA!"

The loss of school instructional time, documented by reports from member schools, clearly shows students miss more instructional class time for family vacations, medical reasons, parental excuses, vocational activities, etc., than they do for all KSHSAA-sponsored school activities combined.

Activities reach out to the community-Activities in our Kansas schools will be as good and as sound as those who administer and support them. Rules and regulations are valueless unless they are embedded in the "grass roots" of the local school and community. The underlying philosophy of interscholastic activities presupposes these rules and regulations are for the good of the students themselves-just as are the other phases of the educational program-and that is the way the citizens of Kansas want them to be

Supplemental BOD Agenda information regarding **Unified Bowling** (Approved 3/24/21 by Executive Board for inclusion on April 30, 2021 BOD Agenda)

Unified Bowling

1. Purpose of Unified Sports®

Dedicated to promoting social inclusion through shared sports training and competition experiences, Unified Sports® joins people with and without intellectual disabilities on the same team. It was inspired by a simple principle: training together and playing together is a quick path to friendship and understanding. Having sport in common is just one way that preconceptions and false ideas are swept away.

2. Definitions

Unified Sports - Special Olympics Unified Sports® is an inclusive activities program that combines an approximately equal number of Special Olympic students with intellectual disabilities and students without intellectual disabilities on teams for competition and inclusive activities fostering an environment of social inclusion. Unified Sports at the high school interscholastic level is a school athletic/activity program that is co-supported by the Kansas State High School Activities Association and Special Olympics Kansas. These teams are administered and supported in a manner similar to other interscholastic athletic teams and activities programs in the schools. Athlete – must be a bona fide undergraduate student in the member school; must have a recognized intellectual disability defined within 42 U.S.C. Section 12102(ADA). **Partner** – must be a bona fide undergraduate student in the member school. Coach – must be employed by member school; must meet requirements of Rule 10. **Team** – "Trio teams" may be comprised of up to five players, three are designated as competitors and remaining two substitutes. The three competing students must include at least one athlete; the coach may allow for a fourth competitor provided the fourth is an athlete. Teams may be co-ed.

3. Requirements

Athlete – must meet all KSHSAA individual eligibility requirements; must have preparticipation forms completed and on file at member school of which they will participate.

Partner – must meet all KSHSAA individual eligibility requirements; must have completed pre-participation physical exam on file at the member school of which they will participate.

Coach – must meet all requirements of Rule 10; must complete NFHS course: Coaching Unified Sports; must attend KSHSAA Unified Bowling Rules Meeting; must complete KSHSAA Unified Bowling Rules test.

4. Season

- A. The opening practice date for Unified Bowling is Monday of SCW 13. (Sept 28, 2020)
- B. The first competition date is Monday of SCW 15. (Oct 12, 2020)
- C. Regional Qualifying Tournament shall be held during SCW 19 (Nov 9-14, 2020)

- D. State Championship Tournament shall be held SCW 20 (Nov 19, 2020)
- E. No student may participate in more than 4 Unified competition days during season exclusive of regional/state.
- F. Members of the Unified Bowling team are not subject to the limitations detailed in Buffer Week.

5. Competition

- A. All competition will follow Baker format with first, fourth, 7th and 10th frame bowled by the athlete.
- B. Substitutes may be made during match or between games with an athlete replacing another athlete and a partner replacing another partner. Once a player is removed from a game, they may not re-enter that game.
- C. Matches will consist of 6 games, with total of all games bowled as the team score; the highest total pinfall is declared the winner. In case total pinfall is even, a tie is declared (there are no tiebreaking protocols).
- D. All members of the team bowl on the same lane. The first three games are bowled on one lane. After three games, teams switch lanes with an opposing team.
- E. Schools may compete in duals, triangulars, quadrangulars, or tournaments.
- F. Bumpers are not used.

6. General

- A. Schools participating in unified bowling will be placed in one classification.
- B. Cooperative agreements may be in place between member schools.
- C. The eight-semester rule may be waived for athletes, however, they may participate for a maximum of four seasons in high school career.
- D. All students are subject to age requirements; athletes may only participate beyond designated age provided an AGE Hardship is approved and student has four or few seasons, and the student has not turned 21.
- E. Outside competition is not approved for students during the time they are participating in Unified Bowling.
- F. During the regular season, a school determines how many teams they will maintain.
- G. During postseason (regional/state) only one team will be entered in and represent the school in competition.
- H. This activity will be conducted in partnership with Kansas Special Olympics.
