# Minutes



Executive Board Meeting KSHSAA Board Room Wednesday, January 15, 2020 Thursday, January 16, 2020

Note: Minutes are subject to approval by the Board at its next meeting.

The Executive Board met in the office of the Kansas State High School Activities Association on Wednesday and Thursday, January 15-16, 2020, with the following in attendance: President Alan Stein, Shannon Haydock, Deena Horst, Mike Kastle, Penny Lane, Monty Marlin, Pam McComas, Mark Meyer, Roger Perkins, Matt Renk, Greg Rosenhagen, Ken Stonebraker, and Bill Faflick, Executive Director. Assistant Executive Directors Cheryl Gleason, Francine Martin, Mark Lentz, Jeremy Holaday, Craig Manteuffel, Rod Garman and Office/Operations Manager Brent Unruh were also present.

The minutes of the November 20-21, 2019, meeting were approved.

Items approved by KSHSAA staff on behalf of the Executive Board were reviewed. A list of these items may be found at the end of these minutes.

### ADMINISTRATIVE REPORTS

The Board received reports from Executive Director Bill Faflick, and the Assistant Executive Directors regarding the status of programs and services of the Association. The Executive Director gave a financial report and also an update on the business of the National Federation of State High School Associations following the recent NFHS Winter meeting which Mr. Faflick attended, as well as an update on the business of National Interscholastic Administrators Association following their annual conference and attended by Ms. Martin.

## **BOARD OF DIRECTORS and APPEAL BOARD ELECTION REMINDER**

Member schools are reminded of upcoming elections for positions on the KSHSAA Board of Directors and Appeal Board. An email was sent on January 16th providing information on positions for members of local boards of education and junior high/middle and senior high school administrators. Individuals interested in being candidates for these positions must submit their names to the KSHSAAby February 15. Please see **Bylaws IV and VII** in the Handbook for the required procedures to submit candidate names. The February issue of the *Activities Journal* will contain a special section with this information.

Senior high school principals should note information reminding them to identify their league affiliation and league representatives to the KSHSAA Board of Directors for 2020-2021 was sent to them via email on January 16th.

### BOARD OF DIRECTORS APRIL AGENDA DEADLINE REMINDER

Per Amendments Bylaw, Article XVI in the KSHSAA Handbook, member schools are reminded Friday, March 20, 2020 is the deadline to propose KSHSAA Handbook rule changes for consideration by the Board of Directors at their next meeting, May 1-2, 2020.

## SPORTS MEDICINE & STUDENT SAFETY

The Executive Board heard a report and discussed concussions and collection of concussion data. The Executive Board also received an update on an invitation to partner with the Kansas Athletic Trainers Society (KATS) and the Korey Stringer Institute (KSI) to further risk minimization education and services for Kansas students and member schools through collaboration.

### KSHSAA "SPIRIT OF SPORT" & "HEART OF THE ARTS" AWARDS

Assistant Executive Director Rod Garman reported on nominations received for this year's awards program. The selection process in determining a state honoree for the KSHSAA award in each category continues to involve the KSHSAA Student Advisory Team. The SAT is in the process of evaluating all nominations received and will select the Kansas recipient in each category. Both Kansas honorees will then be forwarded to the National Federation of State High School Associations as the candidate representing Kansas for consideration for national level awards.

### HALL OF FAME

The Executive Board received minutes and report following the selection meeting for the 2020 KHSAA Hall of Fame Committee. Five individuals were selected from 24 qualified nominees. Those selected are coach Gary Cornelsen (Amarillo, TX), administrator Charlotte Davis (Mission), student Jack Sock (Overland Park), coach Kimbrook Tennal (Centralia), and student Renee (Zimmerman) Wilson (Sterling). More information on these individuals is available at the Gallery of Champions at *kshsaachamps.org*. Additionally, the revised selection process was reviewed and approved by the Executive Board.

### GAME DAY DANCE SHOWCASE

Following a presentation from Varsity Spirit representatives Jamie Graham and Kelsey Scheffer regarding a Game Day Dance Showcase, the Executive Board approved a partnership with Varsity Spirit to plan and execute a Game Day Dance Showcase starting in the fall of 2020. Initially, the Dance Showcase will be held in conjunction with the Spirit Showcase (Dance on Friday, Cheer on Saturday) at the Stormont Vail Events Center.

### STATE CHAMPIONSHIP VENUES

The Executive Board and staff discussed the challenges associated with identifying and securing facilities for all state championship contests. Following discussion regarding potential changes in tournament format, the Executive Board asked that the staff prepare a roster of recommendations for change to be discussed, revised, and considered at a future Executive Board meeting.

### CLASS 1A DIVISION POSTSEASON

Following the recent approval/adoption of two divisions in class for 1A for Basketball, Scholars Bowl, and Volleyball, the Executive Board approved competition formats for respective post-season tournaments effective with the new classification in the 2020-21 school year. The Executive Board approved:

Basketball – Elimination of regional tournaments; development of 16 sub-state tournaments (eight per division) with of 6-7 teams each; seeding on Saturday of SCW #33; Sub-state quarterfinals on Thursday-Friday of SCW #34 at higher seeded team; Semifinals on Thursday and Friday of SCW #35 and girls and boys finals on Saturday of SCW #35; one additional state tournament site will need to be identified and secured.

**Scholars Bowl** – Four 1A Division I and four 1A Division II regional tournaments on Thursday of SCW #31 with 14 schools per regional site; top three schools advance to state from each regional (total 24 advance) with 12 each in respective Divisions; state remains on Saturday of SCW #32; one additional state tournament site will need to be identified and secured.

**Volleyball** – Elimination of regional tournaments; development of 16 sub-state tournaments (eight per division) of 6-7 schools each will be Saturday of SCW #16 with single elimination format; one additional state tournament site will be identified and secured for our championship on Friday (pool play) and Saturday (bracket play) of SCW #17.

## GIRLS WRESTLING CHAMPIONSHIP UPDATE

The Executive Board received a report providing an update on the upcoming girls wrestling championship format. In this inaugural year, all classes are combined for two regionals (hosted by McPherson and Paola) and the top six finishers at each of the two-day regionals will qualify for the one-day state tournament to be held in Salina at the Tony's Pizza Event Center on Thursday, February 27, 2020.

### BONA FIDE MOVE DEFINITION DISCUSSION

Staff reviewed the definition of a bona fide move as it relates to student transfer and shared interpretations of what constitutes a bona fide move. This information will be finalized at the March meeting with the intent to share content as part of professional development opportunities provided for building activity administrators.

### **KIAAA CONFERENCE**

The Executive Board requested input on a mandatory exclusion policy for coaches following ejection from a contest. This will be submitted as a Classification Forum question for the spring KIAAA Conference. It was noted Cheryl Gleason will represent the KSHSAA at the KIAAA Board meeting at this conference as Francine Martin will be on NFHS business. The administrative team will provide a report on Association business to attendees at the conference.

#### **OFFICIATING FEES**

On an annual basis, the Association reviews officiating fees in a planned three-year rotation of all sports. KSHSAA staff provided the Executive Board with information on postseason officiating fees in the activities of soccer, swimming & diving, track & field and area supervisors. Staff provided the Board with an analysis of the fiscal impact if fees were to be increased. Following preliminary analysis, the Board referred this item to the agenda of their March meeting for final consideration.

### 36-HOLE GOLF STATE TOURNAMENT QUALIFYING PROCEDURE

The Executive Board received follow up materials regarding the impact of adopting a girls golf regional format with three tournaments instead of the current practice of four tournaments. Following discussion, the Executive Board approved the new format of three regional girls golf tournaments with the top four teams at each regional advancing to the state championship tourney.

## INCLUSION OPPORTUNITY FOR STATE TRACK & FIELD

The Executive Board voted to approve the addition of four additional events at the State T&F Championship meet for wheelchair athletes. Those events include the Girls Wheelchair 400m and Boys Wheelchair 400m to be contested on Friday afternoon between the two preliminary sessions, and the Girls Wheelchair 100m and Boys Wheelchair 100m to be contested Saturday afternoon immediately following the Boys 100m Final. More information regarding rule for wheelchair competition will be posted on the Track & Field page of the KSHSAA website.

### MIDDLE SCHOOL LEAGUE PLACMENT HEARIING

Per Bylaw ARTICLE XV, League Affiliation, the Executive Board conducted a league placement hearing for the following schools with the identified representatives: Hutchinson Public Schools, USD 308 – Superintendent Mike Folks, Principal Michael Self (Hutchinson Middle School), Principal Nathan Henry (7th Grade Principal, Hutchinson Middle School), and District Athletic Director Kevin Armstrong;

McPherson Public Schools, USD 418 – Superintendent Gordon Mohn, and Principal Brandon Simmelink, Athletic Director Inge Esping (McPherson Middle School)

Newton Public Schools, USD 373 – Superintendent Dr. Deborah Hamm, Principal Bobbi Jo Grieb (Newton – Chisholm Middle School), District Athletic Director Brian Becker, and Activities Director/Assistant Principal Joey Menninga (Newton - Chisholm Middle School);

Following presentations and discussion, the Executive Board placed all five petitioning schools into the Wichita Suburban League effective the 2020-21 school year. Note: a conflict of interest was declared for Shannon Haydock, Penny Lane and Ken Stonebraker. They did not participate in the discussion or decision.

### TENNIS TIE-BREAKING PROCEDURE

Following discussion, the Board adopted revised tie-breaking procedures for both regional and state championship tournaments with these changes for immediate implementation. The new procedure for teams tied for the same place at regionals will be to compare the greatest number of entrants followed by a comparison of the most entrants to reach the semifinals. The new procedure for state tennis will be to compare the number of entries from each team earning medals and then to compare the number of pointes earned by team medalists. If the tie remains after each, both teams will be declared tied. The Executive Board also approved a revise point scale for state tournament scoring.

### **RULE 10 BOWLING COACHES**

This past month, administration became aware of concerns relative to bowling coaches and the opportunity to work with students during the school year and outside the season of sport. The board reviewed correspondences and following discussion, affirmed that bowling coaches and participants are subject to all rules for seasons of activities, outside competition, and coaching restrictions.

### FINANCIAL SOFTWARE APPROVAL

Following discussion, the Executive Board approved a transition to use Quick Books as the platform for all financial accounting and reporting purposes.

### CENTRAL PLAINS LEAGUE SPORTSMANSHIP SUMMIT

Board member Rosenhagen provided a follow up report from the CPL Sportsmanship Summit held this past fall.

#### SUMMER COACHING RESTRICTIONS

The Executive Board continued discussion relative to rules surrounding the summer coaching for school staff and impact on students and school communities. Staff will provide summer restrictions for other geographically proximate states for review at an upcoming Executive Board meeting

### ADDITIONAL ITEMS FROM THE FLOOR

The board was apprised of repeated concerns expressed by a variety of sources regarding allegations of undue influence surrounding a school basketball program.

The board supported the one-time approval for selected Kansas students to participate in a scrimmage against USA Softball National Team per Handbook *Rule 4-United States Olympic Committee-Sponsored National Trials and Competitions*.
