The Executive Board of the Kansas State High School Activities Association met virtually via Zoom meeting platform on Wednesday and Thursday, June 17-18, 2020, with the following in attendance: President Alan Stein, Shannon Haydock, Deena Horst, Mike Kastle, Penny Lane, Monty Marlin, Pam McComas, Mark Meyer, Roger Perkins, Matt Renk, Greg Rosenhagen, Ken Stonebraker and Bill Faflick, Executive Director. NOTE: Per Bylaw Article V, Sec. 4, new Executive Board members elected at the April Board of Directors meeting, shall attend the June Executive Board meeting as observers and for orientation. Jason Herman was present as a new member observing the meeting. President Alan Stein participated with Mr. Faflick in an orientation session with Mr. Herman.

## CONSENT AGENDA ITEMS

The following items were approved unanimously via consent:

- Minutes of the April 30-May 1, 2020 Executive Board meeting.
- Minutes of the May 1, 2020 newly elected Executive Board meeting (following the conclusion of the Board of Directors meeting).
- Items approved by KSHSAA staff on behalf of the Executive Board. (A list of these items may be found at the end of these minutes.)
- A budget hearing for the 2020-21 school year was authorized to be held on September 16, 2020 at 11:30 a.m. in the KSHSAA Office. The Association budget for the 2020-21 school year will be finalized at that time. Interested parties are welcome to attend.
- To ensure the KSHSAA remains in compliance with the Kansas Open Records Law, the Executive Board voted to designate the Executive Director or his designee, as the "Freedom of Information Officer." Additionally, the Executive Director or his designee will serve as the "Custodian of the Records" for purposes of the Open Records Law.


## PUBLIC FORUM

None present.

## ADMINISTRATIVE REPORTS AND UPDATES

The Executive Board heard reports from the Executive Director and administrative staff regarding the status of programs and services of the Association. Staff reported key communications regarding general operations, including information regarding the traditional conclusion of the school year. The Executive Director provided a financial report, inclusive of available cash (checking), investments, and restricted funds.

## COVID-19 PLANNING

In response to the continuing impact of the national health crisis, the staff provided updates and discussion opportunities for the Executive Board regarding a draft of the pillars of health relative to a return to school activities, the financial planning to address revenue concerns, the development of contingency plans for activities, the status of in-person rules meetings for officials and coaches, and the status of Kansas Coaching School.

## CHAMPIONSHIP AWARDS

State medals were not awarded for the spring 2020 season, however, the KSHSAA maintains the full inventory for those championship activities. Staff provided an example of refurbished "old" medallion and reviewed a cost comparison of refurbishing versus new medals. The Executive Board supported the recommendation for new medals to be used for the spring of 2021.

## HALL OF FAME COMMITTTEE MEMBERS SELECTED

Kim Lohman, retired A.D., Lakin, and Bill Lowry, Superintendent at Otis-Bison and Stockton were appointed to the Hall of Fame Selection Committee. They will replace Mark Goodheart, retired Principal, Bison and Jean Ney, retired music educator, Bonner Springs, who have completed four-year terms on the committee. Bob Jackson, retired Superintendent, Logan, was appointed to serve as chair of the committee for 2020-21.

## REVIEW OF MEETING NOTES

On May 1, as part of the Board of Director meeting, breakout sessions were conducted per classification. In addition to those needing to elect new Exec Board representatives, all breakout groups processed through a series of questions. The Executive Board reviewed and discussed the notes summaries and empowered staff to address emerging themes.

## GOLF MANUAL UPDATE

The Executive Board approved an update to the Golf manual to now include the following statement: "Participants will be permitted to carry a cell phone in their golf bag for emergency use only. The use of the phone for any reason other than for emergency communication will be subject to disqualification."

## FOOTBALL GATE RECEIPT PROTOCOL REVIEWED

The Executive Board supported efforts to address the week 9 football revenue sharing (Class 4A, 5A, 6A) by referring this issue to Regional Administrator meetings. The focus will be to address possible modification to the revenue sharing amounts between home and visiting schools (after payment of game officials). This will be a topic for the October Regional Administrator meetings.

## GIRLS WRESTLING UPDATES

The Executive Board approved adoption of updates to have four two-day regional tournaments and a two-day single class state tournament with 16 girls qualifying per weight class. They also approved the addition of one more weight class for girls, increasing the total to 12 weight classes. For the next year, girls regional tourneys will be February 12-13, 2021 and the state championship February 24-25, 2021.

## MUSIC MANUAL UPDATE

The Executive Board approved updating the Music manual to include language indicating music support staff(accompanists, color guard and flag corps staff, etc.) are to be employed and paid by the school per written agreement.

## VOLLEYBALL MANUAL UPDATES

The Executive Board approved updates to the volleyball manual per the following:
A. Warm up procedure postseason of 20 minutes includes alternating 4-minute increments for visiting and home teams following 4 minutes of shared court time. The 10 minute warm up begins with 2 minutes of shared time followed by 4 minutes each for visiting and then home team.
B. Warm up procedure regular season is at the discretion of the host school and/or league policy; it is not under the jurisdiction of match officials.
C. The State Tournament time schedule was adjusted to allow the Saturday time schedule to begin one hour earlier with session one starting at 9:00 a.m. and session two starting at 1:00 p.m.

## TENNIS MANUAL UPDATE

The Executive Board approved, pending future Board of Director modifications to Rule 41, the option of allowing regional tennis tournaments with $33+$ schools to be conducted in a one-day format provided they are utilizing 8+ courts for competition.

## VIRTUAL DEBATE

The Executive Board reviewed the proposal provided by the KSCA to allow for virtual debate to occur should the need exist in the upcoming school year due to impact of COVID-19 on this activity. Following discussion, and clarifications provided by staff and from Tim Ellis (Debate/Speech coach from AuburnWashburn Rural HS), the Board approved virtual debate competition for the upcoming year noting that the 500 road mile competition rule would still be applicable.

## OFFICIALS

The Executive Board approved the implementation of a "zone mileage reimbursement" protocol for regional and substate officials assignments.

## CROSS COUNTRY REIMBURSEMENT POLICY

The Executive Board approved modifications to the process detailing compensation for regional cross country host sites to allow for a more equitable manner of the distribution of receipts.

## SCHOLARSHIP AND TRANSFER ELIGIBILITY

The Executive Board approved following recommended interpretations:
A. It is not considered an approved hardship transfer for a student changing schools when a school does not offer an activity or level of activity.
B. Scholarship eligibility for the fall shall be based upon criteria established at the school attended by the student in the spring of 2020. Specifically, a transfer student may not gain scholarship eligibility when they transfer to a school with a lesser standard, nor may a student lose eligibility when the new school has a higher level of academic accountability (applicable only to the fall of 2020).
C. For the purposes of Handbook Transfer Rule - Rule 18-1-6 Possible Limited Eligibility, a student shall not be considered rostered in any spring activity for the spring of 2020 (applicable only for the 2020-21 school year).

## SPORTSMANSHIP

A staff committee met to discuss and plan upgrades to sportsmanship efforts to be implemented with the new school year. Work includes significant upgrades to the Sportsmanship Manual, including the development of a sportsmanship social media campaign to be implemented this next year. The Sportsmanship Manual will include user ready resources for member schools and leagues.

## PUBLIC/PRIVATE DISCUSSION

The Executive Board reviewed the preliminary results from the Classification survey distributed to member school principals to gather input regarding preferences for possible rules proposal regarding the process used to classify schools. The Executive Board also reviewed recent correspondences, news reports, and championship data regarding public/private schools.

## CPR/AED TRAINING FOR COACH/SPONSORS

When there is a demonstrated need, and only upon specific request, the Executive Board approved staff to suspend, for one year only, the hands-on/in-person requirement for coach/ sponsor CPR/AED training. This is for unique circumstances in communities where face to face instruction is not possible and would only be extended to schools requesting the exception based upon demonstrated needs.

## KSHSAA HANDBOOK UPDATES AND BOD AGENDA DEVELOPMENT

The Executive Board approved the proposed Handbook updates to be placed on the September Board of Directors Agenda impacting Rule 11 and Rule 41 as noted:

## Rule 11, Athletic Officials, Section 2, Article 1

Art. 1: Member high schools shall use officials registered with the KSHSAA in the following varsity sports: boys fall soccer, girls spring soccer, girls volleyball, boys football, girls gymnastics, girls and boys wrestling, girls and boys basketball, boys baseball and girls softball.

NOTE: It is recommended that registered officials be used for non-varsity competition.

## Rule 41, Tennis, Section 1, Article 3

Art. 3: The state tournament
a. Girls - The Executive Board shall establish the state tournament during Standardized Calendar Week \#15. Regional tournaments, when needed, will be held during SCW \#14. In classification groups of 33 or more sehools, a two day regional tournament will be conducted during SCW \#14.
b. Boys - The Executive Board shall establish the state tournament during Standardized Calendar Week \#45. Regional tournaments, when needed, will be held during SCW \#44. In classification groups of 33 or more schools, a two day regional tournament will be eonducted during SCW \#44.

## KSHSAA CONTRACTS AND SALARIES

The Executive Board unanimously agreed to the extension of the contracts for each administrator (Executive Director, Assistant Executive Director, and Office Manager) serving at the KSHSAA. The Board also approved total staff salary allocation of $\$ 1,531,025$ for the 2020-21 school year.

## ADVISORY GROUP RECOMIMENDATIONS

Each year, the Kansas Association of Scholar's Bowl Coaches (KASBC), the Kansas Coaches Association (KCA), the Kansas Interscholastic Athletic Administrators Association (KIAAA), the Kansas Music Educators Association (KMEA), and the Kansas Speech Communications Association (KSCA), survey their membership and develop proposals. These recommendations are tabled and published in the April Executive Board meeting minutes to allow member schools to discuss them and provide feedback. Final discussion and action on all recommendations is undertaken in the June meeting by the Executive Board.

## Recommendations Adopted

The following recommendations, submitted by various advisory groups were approved by the Executive Board:

## Bowling

1. Remove jewelry from the inappropriate attire list in the KSHSAA manual. This would not include smart watches, as they will fall under the category of cellular devices. (KCA)

## Rationale:

- Jewelry does not inhibit an athlete from competing in the sport of bowling. Therefore, jewelry should be removed from the inappropriate attire list.
- By striking this from the KSHSAA manual, the decision of wearing jewelry will be left to the discretion of the coach.

2. Bowlers who are in violation of KSHSAAB Bling Manual policies regarding: possession/use of a cellular device in the competition area; possession/consumption of food/ drink (other than water) in the competition area; use of inappropriate/vulgar language or obscene gestures; inappropriate attire; shall be penalized as follows: (KCA)

- 1st Penalty - Verbal warning from coach. (The coach of the violating bowler/school will be notified by the meet manager regarding the violation and will address the issue with his/her bowler within a reasonable amount of time.)
- 2nd Penalty - Bowler will receive zeroes until in compliance with the violated rule.
- 3rd Penalty - Bowler will be removed from the tournament/event.
- Automatic Removal - Bowler will be automatically removed from the event if damage is caused to the bowling center or its equipment, or if any instances of threats or intimidation occur.

Note: Bowlers that are not attired appropriately will not be allowed to compete.
Rationale: There are many good policies in place, but no consequences for violations.

## Golf

3. (Girls and Boys) Allow up to two salaried school employed coaches to coach at Regional and State. (KCA)

## Rationale:

- There are now more $1 A$ teams with the change in classifications.
- Coaches can now coach anywhere except the green, the assistant coaches would like to be able to coach during tournaments. All other sports allow assistant coaches to coach, they would like to be able to do the same.


## Tennis

4. Eliminate the current rule concerning caps and visors being worn forward. Depending on sunny and/or windy conditions, players often flip their hats around when they change ends of the court. Hats/Visors are to be worn either forward or backwards. They may not be worn inside out nor with the bill worn to the side. (KCA)

## Rationale:

- This has been an ongoing proposal. The coaches support the change.

5. Eliminate "A player suffering from a treatable medical condition equals one (1) medical time-out of three (3) minutes for treatment of that medical condition." Leave current language in the tennis manual to read: "If needed, a player or doubles team is allowed one 10 minute time out per match, per injury." (KCA)

## Rationale:

- To simplify the administration of the rule for the tournament director and coaches, this allows for only one (1) medical time out per match, if needed.

6. Add "Before 12 point Tiebreaker - 90 seconds max". (KCA)

Rationale:

- The tiebreaker determines who wins the set and or match. Coaches often times may have more than one match playing on site or at another site. This allows the coach to talk with their players at a crucial time and may be the only opportunity the coach has had to talk to the players.


## Wrestling

7. (Boys) Should the KSHSAA change the format for 5A/6A State Wrestling quarterfinals matchup to a seed/ geographic match up as noted below? (KIAAA)

Rationale:

## Football

2. (8-Player) Change the format of Districts to place teams into 1st round pools of four. The 1st round pool will still be seeded as a $1 \mathrm{v} 4,2 \mathrm{v} 3$ match up with the winners moving on to face each other in the 2nd round. There will be one team from each district making up these pools of four teams. The district assignments, district point system, and cross-district alignments would not be changed at all. (KCA)

## Rationale:

- Thisformat will bring new cross-district matchups into the 2 nd round of the playoffs and push any potential district rematch back to the Sectional round.

3. (1A, 8P-DI, 8P-DII) Should the KSHSAA change their policy/practice/procedure of postseason football alignment for 1A, 8-Player Division I, and 8-Player Division II? (KIAAA)

Rationale:

Proposed Change: The new playoff format would place teams into first round pools offour (resembling the 3-2-1A State Wrestling format). The first-round pools would feature a \#1, \#2, \#3, and \#4 seed from four different districts. For example, District 5 \#1 would host District 6 \#4 and District 7 \#2 would host District 8 \#3. This format will bring new cross-district matchups into the second round of the playoffs and push any potential district rematches back to the third round (Sectionals).

## Golf

4. (Girls and Boys) Before Regional teams are assigned, schools let KSHSAA know if they are bringing a full team or not. For Girls by SCW 13 and Boys by SCW 43. (KCA)

Rationale:

- KSHSAA could assign an even number of full teams per Regional.
(Note: would like to take Quasi Team state qualifying procedures to RegionalAdministrator Meetings to discuss)

## The Executive Board took no action on the following items, because it is existing policy or because no action is necessary.

## Golf

1. (Girls) Manual Change Recommendation: USGA local rule at girls Regional and State sites for Lost Ball and Out of Bounds. (KCA)

## Rationale:

Pace of play and consistency. Girls have been playing by those rules during the season and this would keep rules the same.

## Wrestling

2. (Girls) Wrestlers weigh in wearing their Competition Singlet/2-piece uniform, the same way girls do for USA Wrestling and other national events currently. (KCA)
Rationale:

- This would allow any official to weigh in girl wrestlers.

3. Should the KSHSAA add to the of NFHS Wrestling Weigh-In Rule 4-5-7, by requiring all wrestlers, male and female to weigh in at competition wearing an unaltered competition uniform (Singlet with Straps up or Fight Shorts/Compression Shirt)? (KIAAA)
