### **REGISTRATION FEES**

The KSHSAA establishes registration fees in accordance with costs of purchasing, printing and distributing materials used by our officials. Dues for NFOA membership are included as part of the registration fee. As approved by the Executive Board, the registration fee for one sport is **\$47 (\$30 for Track & Field)** and **\$25** for each additional sport.

### For officials registered 21 years or more, the registration fee is \$47 for the first sport and \$10 for any additional sport provided you register <u>by July 14</u>.

The KSHSAA will accept registrations for a sport through the registration deadline date listed on the schedule enclosed in this mailing. A <u>NEW</u> official's registration for football, basketball, volleyball, wrestling, soccer, baseball, softball, and track & field is <u>VOIDED</u> if the official fails to complete the required online rules meeting or in-person officials meeting for each sport in which you are registered.

A portion of your KSHSAA registration fee pays your membership in the NFOA. Kansas is a 100% NFOA membership state which means your membership includes access to the NFHS Central Hub through the ArbiterSports website. This section contains officiating educational content exclusively for high school officials including a searchable rules database, publications, video, an official's forum, and more. Your membership also includes NFOA insurance, publications, and other benefits. To complete the NFOA membership, and provide you with NFOA insurance coverage, an official is requested to provide only the last four digits of your social security number with your KSHSAA registration.

### LATE FEES

If you were registered in 2012-2013 for Football, Volleyball, Basketball, Wrestling, and/or Soccer (boys and girls), you must register for the 2013-2014 year by <u>July 14</u> OR pay an additional \$20 late fee. Baseball, Softball, and Track & Field officials must register by <u>January 14</u> OR pay an additional \$20 late fee.

### **OFFICIALS MEETINGS**

In a continuing effort to provide quality training opportunities for our registered officials, the KSHSAA is conducting a series of inperson official's meetings for each sport, every other year. ### **ONLINE RULES MEETINGS**

In the alternate years in which an officials meeting **IS NOT** offered for your sport(s) officials **MUST** complete an online rules meeting. The following sports will require an online rules meeting for 2013-2014:

FOOTBALL SOCCER (Boys & Girls) BASEBALL TRACK & FIELD

Dates the online meetings are available for these sports is included in this mailing.

At the end of the online meeting you will have the option to request the KSHSAA to notify another state of your rules meeting attendance.

KSHSAA registered officials CANNOT receive rules meeting credit by attending an out of state meeting.

### ARBITER INFORMATION

Only KSHSAA registered officials will be available for assignment through Arbiter. THEREFORE IT IS IMPERATIVE THAT YOU REGISTER EARLY WITH THE KSHSAA IN ORDER TO BE AVAILABLE FOR ASSIGNMENT BY COMMISSIONERS/LEAGUES AND SCHOOLS USING ARBITER. Please see the enclosed instructions for the Arbiter assigning system.

### **ONLINE OFFICIALS LICENSE**

**The KSHSAA does not mail licenses.** Officials can obtain a printable version of their KSHSAA license, NFOA membership card, and NFHS Sportsmanship pocket card on your official's page of the KSHSAA website.

### **OFFICIALS DIRECTORY**

The OFFICIALS DIRECTORY will be printed this summer listing all officials who have registered by <u>July 14</u>. This publication will only be mailed to member schools.

### **RECOGNITION AWARDS**

We want to recognize you for your service! Officials with 20 or more years of service as a KSHSAA registered official should login at www.kshsaa.org and complete an Official's Service Award application. Officials can apply for 20, 30, 40, and 50 year awards. The application should be printed, filled out, and sent in to our office at least 30 days prior to the state event at which you elect to receive your plaque. Awards are presented only at KSHSAA state championship events, or can be shipped to your home address.

### **SUSPENSION POLICY**

By action of the Executive Board, effective with the 2006-07 school year, officials who fail to comply with the rules meeting attendance and examination regulations for two consecutive years may be reinstated only after payment of a \$75.00 penalty fee.

### **PUBLICATIONS**

Rules books, examinations and other materials will be sent to you prior to each sport season. This material will arrive in plenty of time for you to complete the open book exam prior to the deadline date, provided you register early.

### IN-PERSON OFFICIALS MEETINGS REQUIRED FOR REGISTERED OFFICIALS

The KSHSAA is committed to providing quality educational and training opportunities for our registered officials. In the most recent KSHSAA strategic plan our member schools indicated that recruiting, training, and retaining officials is a top priority. To work towards fulfilling this priority the KSHSAA will again be conducting a series of in-person officials meetings during the 2013-2014 school year. Please note the following in regards to this requirement:

- Registered officials will be required to attend an in-person officials meeting every other year for each sport in which they are registered.
- The in-person officials meeting fulfills the rules meeting requirement for that year, in that sport.
- If an in-person officials meeting is missed it results in the official being placed on probation the following year.
- There WILL NOT be an online rules meeting option available for officials during the year an in-person officials meeting is required for their sport(s).
- Officials <u>MUST</u> complete their rules meeting requirements online in years when an in-person officials meeting is not offered.

The KSHSAA rules testing process for head high school coaches, head middle/junior high school coaches, and officials will continue to be administered online only. **Officials are required to complete the exam** within the date range for their respective sport(s).

For sports requiring an in-person officials meeting there is NO online rules meeting option. <u>YOU MUST</u> <u>ATTEND THE IN-PERSON OFFICIALS MEETING TO RECEIVE RULES MEETING CREDIT</u>. For sports that do not offer an in-person officials meeting you must fulfill your sport's rules meeting attendance requirement online. The dates the online rules meetings are available to receive credit are listed above.

# PLEASE FOLLOW THESE INSTRUCTIONS FOR TAKING THE EXAM & ATTENDING THE ONLINE RULES MEETING (if applicable to your sport). IF YOU HAVE ANY QUESTIONS, PLEASE CALL THE KSHSAA AT (785) 273-5329.

- 1. To take the exam and/or attend the online rules meeting, go to the KSHSAA web page at www.kshsaa.org and follow the directions below:
- 2. Go to the OFFICIALS tab at the top of the page, click Login, and enter your login information.
  - A. OFFICIALS: Your KSHSAA Officials Number is found on your registration confirmation email and license. For veteran officials, this number does not change from year to year. If you are a new official and have lost your registration confirmation email and license, call the KSHSAA at the number above. Your Password is your initials (ALL UPPER CASE) and the last 4 digits of your social security number. If you have not registered with a middle initial, do not use one in the password field.

- **B.** Officials who have not provided the last 4 digits of their social security numbers will need to do so before they can login and take an exam.
- **3.** Once logged in, you will see a list of sports in which you are currently registered. Select the sport in which you are taking the exam or attending the online meeting. After clicking on the sport, choose the link in the right hand column for the sports exam or online rules meeting.
- 4. Please note the following instructions for taking the Sports Exam:
  - A. Officials who are also head coaches in the same activity should submit their exam as a head coach through the school login. Follow the instructions included in the coach's mailing.
  - B. The exam consists of 50 questions. You may skip around to different questions within the exam, but you must answer all questions before the exam can be submitted. YOU MUST COMPLETE THE ENTIRE EXAM IN ONE SESSION! Logging off with an incomplete exam will result in you losing what you have completed up to that point and requiring you to start the exam over. After completing all 50 questions, click the Submit All button
  - **C.** After completing the exam please print both your answer sheet and question sheet. **Your answer sheet** serves as confirmation of you taking the exam should a discrepancy arise.
  - D. Your score will be posted on your KSHSAA official's web page after the exam has been turned off. ALL ONLINE SCORING IS FINAL.

### 5. Please note the following instructions for attending the Online Rules Meeting:

- **A.** Throughout the meeting there will be sets of questions you must answer. Failure to answer the questions correctly will restrict you from advancing through the meeting. You have the option to review previous slides to find the correct answers. There is no limit on the number of attempts to answer the questions correctly.
- B. Attendance will not be credited until the ENTIRE rules meeting has been viewed and all questions have been answered correctly.
- C. When complete, an attendance certificate will be available for print. PLEASE keep a copy for your records.
- **D.** A combination official/head coach in the same sport is required to view two separate online rules meetings to receive credit for both positions. To access the coach's online rules meeting, login with your school's KSHSAA website credentials.
