Section 15, page 12 specifically deals with late entries for the regional tournament. Schools who enter late will risk being assigned to a location further from their school than one to which they might otherwise have gone. An assignment to a regional site was not made unless **Card #DE-3** was received by the KSHSAA. **Please notify the KSHSAA immediately, if you must cancel your entry in the regional tournament. No refunds will be made in the event of a cancellation.**

**IMPT-** In the case of late cancellations, the KSHSAA may move a school from one regional to a different regional if necessary to balance out competition; thus, making each regional a valuable experience for all.
