The Executive Board of the Kansas State High School Activities Association met in on Wednesday and Thursday, January 13-14, 2021, with the following in attendance: President Alan Stein, Shannon Haydock, Jason Herman, Deena Horst, Mike Kastle, Monty Marlin, Roger Perkins, Greg Rosenhagen, Ken Stonebraker, and Bill Faflick, Executive Director. Assistant Executive Directors Cheryl Gleason, Francine Martin, Mark Lentz, Jeremy Holaday, Craig Manteuffel, Rod Garman and Office/Operations Manager Brent Unruh were also present.

The minutes of the November 18-19, 2020 and the December 11, 2020, meetings were approved.

Items approved by KSHSAA staff on behalf of the Executive Board were reviewed. ***A list of these items may be found at the end of these minutes.***

ADMINISTRATIVE REPORTS

The Board received reports from Executive Director Bill Faflick, and the Assistant Executive Directors regarding the status of programs and services of the Association. The Executive Director gave a financial report and also an update on the business of the National Federation of State High School Associations following the recent NFHS Winter meeting which Mr. Faflick attended, as well as an update on the business of National Interscholastic Administrators Association following their annual conference and attended by Ms. Martin.

BOARD OF DIRECTORS and APPEAL BOARD ELECTION REMINDER

Member schools are reminded of upcoming elections for positions on the KSHSAA Board of Directors and Appeal Board. An email was sent on January 15th providing information on positions for members of local boards of education and junior high/middle and senior high school administrators. Individuals interested in being candidates for these positions must submit their names to the KSHSAA by February 15. Please see **Bylaws IV and VII** in the Handbook for the required procedures to submit candidate names. The spring issue of the *Activities Journal* will contain a special section with this information.

Senior high school principals should note information reminding them to identify their league affiliation and league representatives to the KSHSAA Board of Directors for 2021-2022 was sent to them via email on January 15th.

BOARD OF DIRECTORS APRIL AGENDA DEADLINE REMINDER

Per **Amendments Bylaw, Article XVI** in the KSHSAA Handbook, member schools are reminded **Monday, March 22, 2021** is the deadline to propose KSHSAA Handbook rule changes for consideration by the Board of Directors at their next meeting, April 30-May 1, 2021.

AGENDA ITEMS FOR BOARD OF DIRECTORS SPRING MEETING

Executive Board members discussed the agenda for the next Board of Directors meeting. Two items were introduced by staff for addition to the agenda. Following discussion, the items were approved to be added to the April 30th Board of Directors meeting agenda:

Rule 5 - Classification of Senior High Schools

Section 1: General Regulations (none)

Amendments to general classification shall not be subject to revision for the first three school years upon initial application.

Rule 16 - Semester Requirements

Section 1: General Regulations (apply to grades 7-12)

Art. 1: Once the school determines that a student is promoted from sixth grade, middle school/junior high eligibility begins immediately in the following semester. A student shall not have more than two semesters (the initial year of attendance) of possible eligibility in grade seven and two semesters in grade eight. Once the school determines that a student is promoted from eighth grade, high school eligibility begins immediately in the following semester. A student shall not have more than eight consecutive semesters of possible eligibility in grades nine through twelve, regardless of whether the ninth grade is included in junior high or in a senior high school. **NOTE:** If a student does not participate or is ineligible due to transfer, scholarship, etc., the semester(s) during that period shall be counted toward the total number of semesters possible.

KSHSAA HALL OF FAME

The Executive Board received minutes and report following the selection meeting for the 2021 KHSAA Hall of Fame Committee. Five individuals were selected from 24 qualified nominees. Those selected are coach Shane Cordell (Little River), administrator Gary Musselman (Silver Lake), coach Van Rose (Shawnee), student Jacque (Struckhoff) Stedman (Grinnell), and coach (Ms.) Kim Tennial (Urbandale, IA). More information on these individuals is available at the Gallery of Champions at www.kshsaachamps.org. Board members were also apprised of the status for members of the 2020 Hall of Fame class who were unable to receive their awards due to the pandemic.

STATUS OF ALTERNATIVE FALL SEASON

Five schools, all from USD 500, Kansas City Public Schools, decided to forgo participation in fall activities and to participate in the Alternative Fall Season as approved by the KSHSAA Board of Directors at their special meeting conducted on August 28, 2020. In a subsequent digital discussion, USD 500 was approved to modify the Alternative Fall Season to the dates beginning February 1 and ending March 6, 2021. Following discussion, the Executive Board directed staff to contact USD 500 and provide support for the formation of their alternative fall season.

STATE DIVING QUALIFYING PROCEDURES

The Executive Board approved the staff recommendation to amend the previously approved qualifying procedures for divers to State Championship meet for the upcoming 2021 Boys State Diving championship for classes 6A and 5-1A. For diving only, qualification will be based upon athletes meeting the qualifying mark identified by the 6-dive or 11-dive standard. The adopted protocol limiting entries to the top 24 qualified entries remains in place for all other swimming events.

WRESTLING NON-VARSITY EXTENDED SEASON

With the state wrestling qualifying series beginning earlier than the traditional date, staff brought a recommendation to the Executive Board for relief from Handbook **Rule 30 Seasons of Activities, Section 2, Article 1**. Per Rule 30, the final date for school competition is the same as the date the state championship series is scheduled. Because of this, non-varsity wrestling would conclude competition earlier than normal because of the coronavirus adjusted series for 2021. Per authority granted to Executive Board by the BOD at the August 28, 2020 meeting, it was approved to adjust the rule for the 2020-21 season only so non-varsity wrestling competition could end on a date consistent with the Regional meets (February 18) as long as competition limits (days and points) are not compromised by an individual wrestler.

TICKET PRICES ADJUSTED FOR WINTER POSTSEASON

With restricted attendance policies for the expanded championship series of KSHSAA sponsored postseason events due to the covid-19 pandemic, staff asked for input from the Executive Board on student and adult ticket prices for winter activities. With no spectators allowed for swimming & diving championships in 2020-21, the affected activities are basketball, bowling, and wrestling. Following discussion, the Executive Board voted to amend ticket prices providing single admission price point at the traditional adult price for winter activities.

WINTER CHAMPIONSHIP POSTSEASON PROTOCOLS APPROVED

Staff provided additional detail regarding implementation specifics for winter event postseason protocols. Following discussion, staff recommendations were approved for the following activities: Basketball, Bowling, Scholars Bowl, Swimming and Diving, and Wrestling. All postseason events will be capped at 50% of available seating capacity for spectators with equal access for participating schools; event limits will always defer to more stringent local policies and some event will not have any spectators due to competition, venue, and local restrictions. Digital tickets and vouchers will be used to provide initial access to tickets. Pass lists and bench personnel are limited for all rounds of postseason. Additionally, basketball will clear the arena between both games of the doubleheader and separate admission will be assessed for each game. Additional sport specific information will be provided via newsletters and direct communication from hosts and KSHSAA staff.

REVIEW OF SPRING ACTIVITY CONSIDERATIONS

Executive Board members were given considerations for all spring activities in preparation for upcoming season. These considerations are still in the process of review by the SMAC. Activities reviewed were Baseball/Softball, Boys Golf, Girls Soccer, Speech and Drama, Girls Swimming and Diving, Boys Tennis, and Track and Field. Following discussion, the Executive Board approved considerations for the spring activities with allowance for additional changes to be made by the SMAC. Spring sport considerations will be posted by February 1.

SPEECH & DRAMA QUALIFYING AND CHAMPIONSHIP NUMBERS ADJUSTED

Assistant Executive Director Craig Manteuffel provided the Executive Board members with recommendations from KSCA for a reduction in the number of schools required for a qualifying tournament for the 2021 spring season only. Due to the coronavirus pandemic, the number of schools required for a qualifying tournament will be moved down from seven schools to five so schools may keep their participation numbers lower. The state championship qualifying numbers were adjusted accordingly to the following numbers:

- 6-17 – 2 qualify
- 18-29 – 3 qualify
- 30-41 – 4 qualify
- 42-53 – 5 qualify
- 54 or more – 6 qualify

STATE CHAMPIONSHIP VENUES

In preparation for extending contracts for future state championship events, the Executive Board and staff discussed the challenges associated with cross country, volleyball, football, soccer, gymnastics postseason championship venues.

REVIEW OF SPECTATOR PROTOCOLS and CALL FOR SPECIAL BOD MEETING

Executive Board members shared observations on the current attendance policies in place from the Board of Directors special meeting on December 8, 2020. Discussion centered on local league and school needs and the possibility for extending or modifying the attendance protocols through the conclusion of winter activities. Following discussion, the Executive Board determined a special Board of Directors meeting should be called to introduce, discuss, and take action on the following proposed restricted attendance policy:

For the period beginning January 29, 2021 through the remainder of the winter activity regular season for the 2020-21 school year, attendance will be limited to a maximum of four spectators per participant permitted in accordance with local board of education or health department restrictions to allow for appropriate distancing for the facility and in accordance with local admission and attendance policies.

MASKING PROTOCOLS

Staff requested input from the Executive Board for school districts who are subject to mandatory masking of students involved in competitions at their facility. Clarity was needed regarding enforcement for athletes involved in competition from visiting teams as postseason qualifying competition begins. Following discussion, the Board went on record stating for activities at host schools that require masks 100% of the time, visiting teams must wear masks while playing or must forfeit contest and the opportunity to advance through the postseason tournament.

SCHOOLS NON-COMPLIANT WITH COVID19 RISK MITIGATION PROTOCOLS

A progressive protocol was given to Board members to address concerns relative to member school continued deviation from adopted Risk Mitigation rules. Following discussion, the Executive Board approved for staff to take the following actions when a school is found to be non-compliant with covid-19 risk mitigation protocols:

- A. First report – notification to school administration detailing violation and identification of corrective action.
- B. Second report – correspondence to school and district administration.
- C. Third report – school/district administrative appearance before the Executive Board.
- D. Fourth – implementation of Executive Board sanctions including, but not limited to:
 - i. Loss of postseason host opportunities
 - ii. Removal from postseason tournament(s)
 - iii. Suspension of KSHSAA membership for all activities
 - iv. Fines/Special assessments

OFFICIATING FEES

On an annual basis, the Association reviews officiating fees in a planned three-year rotation of all sports. KSHSAA staff provided the Executive Board with information on postseason officiating fees in the activities of basketball, cross country, football and gymnastics. Staff provided the Board with an analysis of the fiscal impact if fees were to be increased. Following preliminary analysis, the Board referred this item to the agenda of their March meeting for final consideration.

KIAAA CONFERENCE

The Executive Board reviewed opportunity to submit items to the KIAAA Classification Forum. It was noted that the traditional April conference dates have been adjusted to June 1-3 in an effort to provide best chance for an in-person conference. The conference will be in Mulvane at the Kansas Star Event Center. Francine Martin continues to serve as the staff liaison to the KIAAA Board of Directors.

TRANSFER RULE

Staff requested the opportunity to discuss **Rule 18-1-10 Transferring Back to Home School** with the Executive Board. The Board was asked to consider potential amendments to ensure language and application of this Handbook rule aligns with intent of Board. Following discussion, the Board requested staff come up with a suitable amendment and referred this item to the agenda of their March meeting.

UNIFIED BOWLING

An initial draft proposal to implement Unified Bowling as a championship series was provided to the Executive Board. It is the intent of staff to continue development of the framework for adoption at the April 2021 Board of Directors meeting. Following discussion, the Board of Directors approved the current direction of staff and requested an item be added to their March meeting agenda.

CONSIDERATION OF CONSULTANCY PROTOCOL FOR THE KSHSAA

In an effort to enhance performance and impact in providing leadership and administration of the interscholastic activity program, staff requested the Executive Board approve the implementation of a consultancy protocol designed to provide feedback to governing boards, member schools, and staff. Results of the consultancy protocol, similar to school accreditation protocols, will be shared with stakeholders. Following the introduction of this protocol, the Executive Board will consider implementation at the March meeting.

ADDITIONAL ITEMS FROM THE FLOOR

- Students who transfer from a non-member school are subject to the detail of **Transfer Rule 18-1-4**. The Executive Board recognized the disparity and challenges for the upcoming spring season and confirmed students would not be restricted to the non-varsity level for the spring of 2021 under provisions of this rule.
- For the state quarterfinal basketball championship tournament, games shall be played on a court with no restraining line for throw-ins (a restraining line is required per NFHS Basketball Rule 1-2-2 whenever there is less than 3 feet of unobstructed space outside any sideline or end-line).
- For the postseason, anytime there are limited seats, all schools participating will have initial equal access for purchase of tickets. For basketball, allocations will be provided to participating schools. For wrestling and bowling, allocations will be provided on a per participating student basis.

The Executive Board entered into Executive Session to discuss personnel matters relative to non-elected Association staff, as well as to discuss the financial affairs of the Association.

CHERYL GLEASON ANNOUNCES RETIREMENT

Assistant Executive Director Cheryl Gleason announced her plans to retire June 30, 2021. Ms. Gleason is serving in her 32nd year of service to the Association. Her educational career spans 45 years in service to Kansas schools as a classroom teacher, coach and KSHSAA Assistant Executive Director. The Executive Board went on record thanking Ms. Gleason for her exemplary work, dedication and service to the member schools of the KSHSAA as well as the youth of Kansas.
