Resolution

WHEREAS, The Kansas State High School Activities Association, Inc. (the "Company") sponsors and maintains the Kansas State High School Activities Association 403(b) Plan as a retirement plan for the benefit of eligible individuals and their beneficiaries, which plan is intended to be a Code Section 403(b) annuity plan (the "Plan"); and

WHEREAS, it has become necessary and desirable to amend and restate the Plan in its entirety.

NOW, THEREFORE, BE IT RESOLVED, the amendment and restatement of the Plan is hereby approved in accordance with the terms and provisions set forth in the proposed document presented at this meeting and incorporated in this Resolution by reference.

BE IT FURTHER RESOLVED, the appropriate officers of the Company are hereby authorized and directed on behalf of the Company to sign the restated Plan document and to take such other and further action as may be necessary or appropriate to carry out the intent and purpose of this Resolution.

OPEN FORUM

The following individual was present and spoke to the Executive Board:

- Dr. Tiffany Dirks, Principal, Olathe-Heritage Christian Academy. Dr. Dirks was accompanied by other Heritage Christian administrative and board leadership team members.

ADMINISTRATIVE REPORTS AND UPDATES

The Executive Board heard reports from Executive Director Bill Faflick and the Assistant Executive Directors regarding the status of programs and services of the Association. The Executive Director provided a review of events and actions completed on behalf of the Board and Association since the previous meeting, including a financial report in conjunction with the financial services director. Administrative staff reviewed fall activities which have been completed and gave a preview of winter activities.

2024 REGIONAL MEETINGS

The Executive Director reported 121 middle/junior and 273 senior high schools were represented by 399 people who attended the seven KSHSAA Regional administrator and Board of Education Meetings. The attendance figures were as follows:

Discussion Topics, Voting Results and Executive Board Actions (NOTE: Detailed votes by Classes and Middle/Junior High Schools are available upon request)

1. **(Golf) (HS Only)** Have Regional assignments seeded geographically. Using the rankings from *KansasGolfScores*, assign Regionals to ensure there are no more than 3 of the top 12 teams in a single Regional. If more than 3 of the top 12 teams are located in a single Regional, KSHSAA will move teams from that Regional to ensure there are no more than 3 of the top 12 teams per Regional. Possible swap teams if a team needs to be moved: The first team ranked 16 or below will be swapped with a top 12 team to accomplish balance.

2. **(General)** *(HS Only)* Quasi Team sports – should factors other than geography be used in establishing regional assignments?

3. **(General)** *(HS Only)* Team sports – should something other than W/L record be used in establishing postseason assignment?

4. **(General)** Should eSports be a sanctioned non-athletic KSHSAA activity?

EB Action: The item was approved by a vote of 11 to 2. The eSports Task Force and staff will prepare an item to be presented to the Executive Board at their January meeting, with the expectation an item will be ready for consideration by the Board of Directors as part of their spring meeting.

5. **(General)** Should the KSHSAA modify the current Ejection Policy to add requirements for coaches and players ejected from contests to serve a one contest suspension?

6. **(General)** Should the KSHSAA modify the current Ejection Policy to add requirements for coaches and players ejected from contests to serve a one contest suspension with an appeal process provided for student ejections?

EB Action: This proposal was approved and policy will be implemented beginning with the 2025-26 school year. The appeal process would require video submission by the school within 24 hours of the infraction. When possible, the KSHSAA will provide a response within 24 hours of submission. The determination will be made by a committee consisting of the KSHSAA Sport Administrator, Director of Officials and Executive Director.

FALL STATE CHAMPIONSHIP EVENTS

At the time of the meeting, seven of ten fall championships were completed thanks to the hard work of the host sites, support staff, and administrative leaders for each activity. KSHSAA staff provided the Board members with a review and learning from each activity. Discussion focused on possible adjustments for future fall postseason events.

BASEBALL/SOFTBALL MANUAL UPDATES

Due to restrictions for pitching in baseball, some member schools requested the KSHSAA consider increasing roster sizes for postseason play. Staff surveyed coaches and provided the Board with those

results. The current roster size is 18 players for all postseason baseball and softball teams. Following discussion, the Board recommended staff reach out to the KCA for further discussion with participating baseball and softball schools.

The Board received a recommend for all postseason softball games to utilize the “double first base” for safety purposes. A survey conducted in the spring of 2024 indicated that 84 percent of Kansas softball playing schools already use one for varsity contests. Following discussion, the Board voted to approve the use of the “double first base” in all postseason softball contests starting in the spring season of 2026.

HONORING VETERANS

An update was given to the Board on the second year of the KSHSAA providing complimentary admission to all active military veterans to football games played during the week of Veterans Day. Announcements were read at games in appreciation of service members during the game. The Board was given a chance to provide feedback to staff and discuss additional ways to honor our nation’s military service members in the future.

UNIFIED BOWLING SEASONS

KSHSAA **Rule 30 – Seasons of Activities** provides four seasons of possible eligibility in grades 9-12. With the fourth annual Unified Bowling Championship conducted on November 19, 2024, the Executive Board was asked about allowing participation for those in 18-21 programs at member schools the opportunity to participate as members of the interscholastic program. Following discussion, the Board confirmed students attending member schools are subject to the same rules regarding the number of allowable semesters of eligibility. If a student continues in the school program for 18-21 year-old students, they are still eligible for no more than eight consecutive semesters beginning upon promotion from eighth grade.

PROPOSED RULE MODIFICATION

After discussion on heat acclimatization rules, the Executive Board voted to approve the following amendments to **Rule 30, Seasons of Activities** for inclusion on the April Board of Directors agenda:

Rule 30 – Seasons of Activities

Art. 9: Beginning Monday of SCW #7, the following practice rules apply to football, boys and girls cross country, fall season soccer, girls volleyball, girls gymnastics, fall season tennis and fall season golf. These rules apply for each student until their first interscholastic competition or Monday of SCW #9, whichever is later.

g. Beginning Monday of SCW #7, dual sport athletes are permitted to participate in practices for both sports on the same day, on consecutive days of the week, but combined practice time may not exceed three hours per day until the student has participated in five days of practice for each sport. After five days of practice in each sport, the student may practice up to a combined five hours per day on an every-other-day basis until their first interscholastic competition or Monday of SCW #9, whichever is later.

UNSPORTSMANLIKE BEHAVIOR

Summary data from fall activities was provided to the Board. This data summarized ejections occurring during fall activities. Per this information, as of November 1, there were 301 reported ejections from Kansas interscholastic activities. Discussion was held on current consequences given for bad behavior and how the KSHSAA can lead our member schools in prevention of unsporting behavior. Discussion was held on changes to the sportsmanship awards during basketball season and other initiatives put in place by schools and leagues in the last year. The Executive Board confirmed the most effective way to address

sportsmanship was to establish expectations, to maintain a physical presence at events, and to respond with an intervention as concerns were observed.

The Board also discussed changes to the ejection policy enacted earlier in the meeting. The ejection policy updates as presented at the Regional Administrator Meetings are highlighted as follows:

Requirements for Ejected Coaches

Any coach ejected from a contest shall be suspended from the next contest at that level and for all contests at any level (in that activity) until the suspension has been served. Additionally, coaches who are ejected from a contest (at all levels grades 7-12) are required to complete the NFHS *Teaching and Modeling Behavior* course prior to coaching in their next game. (The course fee is \$20 and can be completed in one hour.) The next game is defined as the next regularly scheduled day of competition. In addition, the school administrator is responsible for providing the KSHSAA administrator with a copy of the coach's certificate of completion of the online course. (The coach may print this as the final step on the online course.) Recurring ejections result in a requirement to repeat the course.

Requirements for Ejected Players

Any player ejected from a contest for unsporting conduct or behavior shall be suspended from the next contest at that level and for all contests at any level (in that activity) until the suspension has been served. Additionally, any player ejected from a contest at any level of play (grades 7-12) for unsporting conduct or behavior will be required to successfully complete the free NFHS *Sportsmanship Course* online, prior to the KSHSAA and school reinstating his/ her eligibility privileges. The school principal or athletic director is responsible for overseeing compliance of this requirement. There is no cost for the course which takes approximately 20 minutes to complete. Schools are not required to submit the student's certificate of completion to the KSHSAA but should retain it on file. An appeal process utilizing video images from a school designated (Hudl, NFHS Network, or coaches game film) source may be requested by school administration. Such an appeal must be initiated within 24 hours of the ejection.

Ejection Policy for Player, Coach, Spectator Involving an Official

Any participant (player, coach, spectator) who is ejected for making contact with an official, who is ejected for unsporting behavior directed toward an official, or who negatively confronts an official following a contest, shall be subject to a non-appealable suspension from the next contest at that level and for all contests at any level (in that activity) until the suspension has been served. Local school leadership may levy additional sanctions as they deem appropriate.

ESPORTS TASK FORCE

The work of the eSports Task Force is underway. Data collected during Regional Administrator Meetings was shared with the Board. The next steps for the committee were discussed.

MULTIMEDIA POLICY

Based upon concern from member schools regarding students being uncomfortable because they were photographed and/or videotaped by those not affiliated with the contest in which they were participating, staff developed a policy for Executive Board consideration. Following discussion, the policy was approved as follows:

KSHSAA MULTIMEDIA USE POLICY

The member schools of the KSHSAA understand capturing images of student participants before, during, and after competitions/performances allow stakeholders the opportunity to share and reflect upon the experience. It is also a teaching and learning opportunity for student journalists. Photographing or video taping of events should never delay or disrupt an event nor compromise the safety of participants or

photographers. School and event administrators may designate specified areas or times for photographers at any event.

Event/Competitor Pre-scout by Schools

Member school staff or designees may not film any school's activity contest in which they are not a participant without advanced written permission from the principals of all schools involved in a contest/performance.

General Public

1. Spectators of a KSHSAA event may not live stream any event. The host or designee are responsible for approving member schools and members of the media for livestreaming approval.
2. Video or photos should not be taken of individual students if the person taking the video or photos is not directly related to or preapproved by the student or member school administrator to capture video or photographic images.

Media

Professional media should follow expectations and codes of conduct detailed by the Kansas Press Association, Kansas Broadcasters Association, and the KSHSAA.

Note 1 - The language from page 5 of the PPE follows:

The above named student and I have read the KSHSAA Eligibility Checklist and how to retain eligibility information listed in this form. The student/parent authorizes the school to release to the KSHSAA student records and other pertinent documents and information for the purpose of determining student eligibility. The student/parent also authorizes the school and the KSHSAA to publish the name and picture of student as a result of participating in or attending extra-curricular activities, school events and KSHSAA activities or events.

Note 2 - Handbook **Rule 53-1-4** states the following:

Art. 4: *Each member school acknowledges that athletic contests and interscholastic competitions take place in the public. As such, there is no expectation of privacy in the images of student participants, coaches or others involved at such events. The KSHSAA and/or its agents or designees may take, distribute and use photographs of student athletes, coaches, officials and other participants at such events and use the same for publicity, marketing and other appropriate purposes, including event programs. The member school will take appropriate actions to notify its student athletes, coaches and participants of this provision.*

OUTSIDE COMPETITION EXCEPTION DISCUSSED

The KSHSAA Board of Directors heard from the Kansas Bowling Proprietors prior to the April 2024 meeting during Public Forum. The KBP requested the KSHSAA consider opportunities for bowlers to compete in outside events during the interscholastic season as an exception to **Rule 22 - Outside Competition**. In support of their effort, a request from the Kansas Bowling Coaches Association was received and presented to the Executive Board for discussion and consideration of appropriate next steps. Following discussion, the Executive Board took no action and did not advance this item to the Board of Directors. The item will be returned to the KBCA who will need to propose Handbook ready language as well as utilize an alternative method to place this item on the Board of Directors agenda. Consideration should be given to an exception similar to what was recently amended for tennis and golf.

TRACK & FIELD MANUAL UPDATES

With the new qualifying procedure for the state championship meet, staff recommend that regional meets "score" the top seven finishers in each event, which is permissible per **NFHS Track and Field**

Rule 2-1-2. This would require taking eight athletes to finals in field events. Following discussion, the Executive Board made the following decisions:

- a. The top seven finishers will attribute points towards team score in all events.
- b. When preliminaries are conducted in field events, eight will qualify for the finals.
- c. For races on the track requiring preliminaries or semifinals, all lanes should be filled coming out of preliminaries or semifinals for the subsequent round.

Staff will update the Track & Field manual for the upcoming 2025 season.

MARKETING INITIATIVES

KSHSAA staff have engaged with national marketing firms that have an interest in serving as a state partner with the KSHSAA. Staff have met with representatives from Teall Property Group (TPG) and Playfly. Both companies work with other state associations. The Board was given an overview of these discussions and directed staff to provide further information at future meetings.

OLATHE HERITAGE CHRISTIAN BOYS BASKETBALL VIOLATION

A member school, Olathe-Heritage Christian Academy, self-reported violations of **KSHSAA Rule 9, Section 2, Article 1 – Moratoriums Fall Athletic Buffer Week; Rule 33, Section 1, Article 4 – Basketball Summer Contact;** and **Rule 33, Section 2, Article 1 – Basketball Beginning Practice Date;** for contact outside the season of sport made by their boys basketball coach and team. In response, staff recommend three specific remedies including a recommended suspension of the coach, a one-week moratorium on practice for the team, and the loss of the privilege of participating in postseason this school year for the boys basketball team. Discussion was held on the severity of violations, additional consequences the KSHSAA could impose and proposed additional remedies by the school.

Following discussion, the Executive Board voted unanimously to apply the following remedies to the identified violations:

- a. Recommendation to impose an indefinite suspension of the boys head basketball coach, with no potential of return until the start of practice for the 2025-26 basketball season.
- b. The Olathe Heritage Christian boys basketball team will not conduct team practices until Monday, December 2, 2024.
- c. The Olathe Heritage Christian boys basketball team will not participate in KSHSAA postseason at the conclusion of the 2024-25 season.

It is noted by the Executive Board, the KSHSAA rules allow for suspension of the entire season for violations of this magnitude and leniency was expressed with these remedies due to the self-report by the Heritage Christian administration.

PHYSICAL EXAM DATE CHANGE DISCUSSED

The Sports Medicine Advisory Committee (SMAC) received a request from a physician group to modify the acceptable period for an exam by amending **Rule 7 – Physical Examination and Parent Consent** which details in **Article 1, Section 5** *“The Physical Examination shall not be taken earlier than May 1 preceding the school year for which it is applicable”*. The SMAC discussed this information during their September meeting and will revisit the topic during the spring meeting but asked the Executive Board to provide feedback on the impact of a possible date change to schools and students. Following discussion, the Board expressed support for the SMAC to continue reviewing data and possible changes to the rule.

DRONE POLICY UPDATES

Since 2015, the KSHSAA has used a policy prohibiting the use of aerial drones at all postseason contests and events. With new advancements in technology, staff discussed with the Board limitations this policy has created for member schools. A review of the current policy was conducted along with policies from other state associations, and staff provided an updated policy for consideration at the January meeting.

FOOTBALL CLASSIFICATION CHANGES

Leading up to the Board meeting, staff were alerted that as many as five schools currently playing football would like to change their classification in the middle of the current two-year scheduling cycle. Schools may be seeking to move from 11-player to 8-Player, from 8-Player to 6-Player, or from 6-Player to 8-Player. The Board held discussion on these changes and the impact upon member schools who have created a schedule for the 2025 season with these schools. Following discussion, the Board determined that any school unable to complete the two-year cycle for football, shall forfeit games and then participate only at the non-varsity level for the remainder of the year. Schools are forfeiting the opportunity to play on traditional varsity nights, and they remain accountable for any contracts extended to officials.

LIMITED ELIGIBILITY TRANSFER REQUEST

Burrton High School had no basketball season last year because of a lack of numbers but fielded a mixed team basketball to participate in three games during the mid-season tournament they hosted. A student who participated on the Burrton mixed team transferred to Halstead High School, which has generated a request for an exception to **Rule 18, Section 1, Article 6 – Limited Eligibility Transfer**. This component of the transfer rule, as written, allows a student who participated in an activity in the previous year to be eligible only at a non-varsity level in that rostered activity. Halstead requested eligibility for the student at the varsity level since she only played in 3 games with the mixed team. Following discussion, the Board made no motion for an exception, resulting in the current application of 18-1-6 being maintained.

EXECUTIVE SESSION

At the request of the Executive Director, the Board entered an Executive Session on Wednesday, November 20 at 3:16 p.m. to discuss legal issues relative to two specific legal matters in which counsel has been engaged. Following the session, the Executive Board reconvened at 3:32 p.m.
