Agenda Item 1 (Basketball Shot Clock)

From the perspective of veteran Kansas **game officials**, the following was provided relative to the inclusion of the shot clock at the interscholastic level:

- 1. Training for officials and bench personnel will be critical.
- 2. Most difficult job at the scoring table is the shot clock (need to be very knowledgeable).
- 3. Will eliminate discernment as on intentional fouls as all will be two shots.
- 4. Varsity only or also at non-varsity and MS levels?
- 5. One more thing to go wrong.
- 6. One more thing to generate challenges.
- 7. No instant replay (frequent college instant replay request surrounds shot clock issues).
- 8. May help the flow of some games.
- 9. Eliminates strategy employed by some teams.
- 10. Really takes both teams to stall now one team does not have to play defense for extended period of time.
- 11. Potential deterioration of basketball skills.
- 12. May lose officials as this puts more pressure on officials to monitor one more thing.
- 13. More conflicts between coaches and officials.
- 14. Some tables are not equipped for shot clock operators.
- 15. Promotes quicker play, more action.
- 16. Associated costs.
- 17. More zone defenses.
- 18. Game stoppages at critical juncture of games is possible while officials respond to possible timing errors.
- 19. Good games may be better, but bad games will be worse.

## Host requirements:

18" between three-point line and sideline (in the corner)

Quarterfinal capacity of 500

Semifinal and final seating capacity of 1200 for Classes 2A and 3A

Semifinal and final seating capacity of 1000 for Class 1A DI

Semifinal and final seating capacity of 750 for Class 1A DII

No restraining line for Classes 2A and 3A (all rounds)

No restraining line for Classes 1A DI and 1A DII in semifinal and final rounds

2022-23 SY data reflects 12 schools in 2A that could not host.

# Main Tenets

- 4 Regions of 16 teams
  - Seed 1-16
    - Groups: 1, 4, 5, 8, 9, 12, 13, 16 and 2, 3, 6, 7, 10, 11, 14, 15
    - Boys and girls play different nights for all rounds
- 1st round play at higher seed
- 2<sup>nd</sup> round play at highest able to host in each group (likely 1 and 2)
  - If 1 and 2 lose in first round they still host the two 2<sup>nd</sup> round games
  - 2 games in one night at each site
  - We have to know where to assign officials
  - After 2<sup>nd</sup> round, each group has two teams remaining
    - Reseed each of the four teams left in each region

# Main Tenets


- 3<sup>rd</sup> Round ("Sub-State Finals") one game each night
  - Match up against region next to you
  - 1 and 2 in Region A host 3 and 4 in Region B
  - 1 and 2 in Region B host 3 and 4 in Region A
- Possible for four teams in the same region to advance to round of 8
- Top 2 seeds in each region play three home games
- Increased travel within region and outside of region

# Main Tenets

- Requirements to host a post-season game
  - 1A-DI & 1A-DII
    - First round
      - Minimum capacity 500
      - Minimum 18 inches between sideline and three point line in corner
    - Second and third round
      - 1A-DI: Minimum capacity 1000, no restraining lines, 18 inches three point line to corner
      - 1A-DII: Minimum capacity 750, no restraining lines, 18 inches three point line to corner
  - 2A & 3A
    - All rounds: Minimum 1200 capacity, no restraining lines, 18 inches three pt line to corner




# Basketball 1A DI - Group of 16 #2





# **Regional Qualifying Proposal:**

## 3.A Regional Entries

### 3.A.1 Contestant Event Limitation (No changes)

#### 3.A.2 School Event Entry Limitations (Changes in red)

Schools may submit individual event entries for the girls and boys regional track and field meets as follows:

Class 6A, 5A, and 4A - may enter three (3) entries per individual event without meeting the qualification standard;

Class 3A, 2A, and 1A - may enter two (2) entries per individual event without meeting the qualification standard;

All Classes (6A-1A) - may enter **all** athletes per individual event provided all entries in that event from that school have equaled or bettered, in a bona fide interscholastic varsity level competition this season, the qualification standard.

#### 3.A.3 Qualifying Standards (M) (No changes)

Adjusted to the average of the average sixth-place regional finisher for the last five years.

#### Rationale:

Qualifying standards are based on the past 5 years and have been used at the 3A, 2A, and 1A levels with fidelity and should be extended to the 4A, 5A, and 6A levels as well in order to ensure that the best athletes are able to compete at regionals.

If a student-athlete meets the qualifying standard for regional participation, they should be allowed to compete.

There should not be a limitation on how many student-athletes from a school can participate in a regional competition.

Zero regional events were full this year.

A full event would be 27 participants in 4A-5A-6A. The largest event entry was 24 - still three short of a full event based on criteria. This (24 entries) occurred in only 7 out of 108 possible events. Therefore allowing a 4A-6A school to bring more than 3 qualifiers would not add or create problems for the meet.

In 1A-2A-3A, a full event would be 48 entries. The largest two entries from regionals were 30 and 35 participants. The majority of the events had between 16-18 participants. Therefore allowing a 1A-3A school to bring more than 3 qualifiers would not add or create problems for the meet.

### **State Qualifying Proposal:**

The top three (3) in each regional automatically advance to the state track and field championship. The next best four (4) qualifying times/distances/heights from each regional competition advance to the state track and field championship.

A maximum of 7 competitors/relays from each regional could potentially qualify for the state meet.

In the event of a tie:

- 1. Ties to be broken based on placement at the regional meet. Ex. 4th place at Regional meet A would be ahead of 5th place at regional meet B.
- 2. In the event that a tie cannot be broken (WHAT WAS THE OLD CRITERIA? When they used to do the two best fourth place finishes?)

#### Rationale:

The top three from each regional would qualify for state, ensuring that the state geographically is well represented. The next 4 best overall, in each regional, would qualify to ensure that the best athletes will be at the state track meet.

Regionals that are highly talented in one event and not the other would be balanced out with additional spots open to the highest qualifying athletes.

Allows for the top three to qualify from all regionals in the event that there is a weather issue at one of the regionals.

Rule change only has an impact on 4th-place finishers from a regional.

All regionals are FAT and live - athletes know if they qualify for state the same day based on the results.

With the change to a 9-lane track in Wichita, this could easily be expanded to include the best 6 from across the state for a total of 18 entries into the state meet.

Volleyball, item 10 (classes 1-3A)

## Volleyball Tournament Sub-State Proposal – Classes 1A-DI, 1A-DII, 2A, 3A

Should the KSHSAA split the State into four groups of up to 16 teams, and create two substates?

#### Proposed model:

- 1. Volleyball seeding would take place on Sunday of SCW #15
- 2. The group of up to 16 will be established via geography.
- 3. Once created, the group of 16 is separated into two sub-states based on records, for each group of 16:
  - a. Sub-State A: Seeds 1,4,5,8,9,12,13,16
  - b. Sub-State B Seeds 2,3,6,7,10,11,14,15
- 4. On Monday or Tuesday of SCW #16, competition within each regional quad all played at the highest seed of each quad (2 courts at each host site if needed):
  - a. Sub-State A Quad 1: (1, 8, 9, 16)
  - b. Sub-State A Quad 2: (4, 5, 12, 13)
  - c. Sub-State B Quad 1: (2, 7, 10, 15)
  - d. Sub-State B Quad 2: (3, 6, 11, 14)

The top two teams from each quad will advance, using the same criteria used at the state to determine who advances from pool play.

- 5. Saturday of SCW #16 will be two-4 team brackets with winners advancing to the State Tournament. Matches will be played at the highest seed of each bracket.
  - a. Seeds 1-4 are the Quad winners, ranked in order of overall winning record percentage
  - b. Seeds 5-8 are the quad runner-ups, ranked in order of overall winning record percentage
  - c. Seeds 1, 4, 5, 8 are bracket 1 (winner of the bracket advances to State)
  - d. Seeds 2, 3, 6, 7 are bracket 2 (winner of the bracket advances to State)
