Thank you for becoming a registered basketball official in Kansas for the 2023-2024 school year. Student-athletes depend on you for a fairly officiated contest. Communities, schools and coaches also depend on you. Enclosed are your basketball officiating materials, please review all materials included carefully! Thank you in advance for your efforts to provide a memorable and rewarding experience for student-athletes in Kansas.

#### **Official Rules Meetings**

Enclosed are the dates of the official in-person rules meeting for 2023-24, these meetings will take less than 1 ½ hours. Attendance is required to become postseason eligible. This year officials must attend an in-person rules meeting.

#### **Rules Test**

The exam questions are included in this packet. The exam will be turned on to submit answers on October 4, 2023. All coaches and officials are sent 55 questions as a study guide. Five of the questions will be video questions. You will not be able to view the video questions until you log into ONCORE <a href="https://app.oncorebycentury.com/Default?kshsaa=1">https://app.oncorebycentury.com/Default?kshsaa=1</a> and begin the exam. You can watch the video questions multiple times when you are completing the exam before selecting an answer. Questions will be in a random order. Failure to submit the exam answers by November 19 will result in the official being placed on probation. A passing score on the open book exam is 90%.

#### **Rules Books**

Enclosed are the 2023-2024 NFHS basketball rules book and casebook. The 2023-2025 Basketball Officials Manual is new this year and should be saved as this is a <u>two year</u> publication. Only new officials will receive the NFHS Basketball Officials Manual next year. *The NFHS Preseason Guide* is included and officials should bring it to the area meetings.

#### KSHSAA Basketball Manual

We are no longer mailing the KSHSAA Basketball Manual to officials. You can find the manual by logging in as an official and going to the Forms tab at the top of the page.

#### **Area Supervisor Meetings**

All officials should attend Series 1 and Series 2 area supervisor meetings. A schedule is included. Officials wishing to be eligible for postseason opportunities must attend both meetings, one Series 1 meeting and one Series 2 meeting. Approved LOA make up meetings will be posted on the KSHSAA website. If you have a valid reason for missing a Series meeting and wish to make up a meeting you must request a make up meeting by contacting Kyle Doperalski (<a href="kdoperalski@kshsaa.org">kdoperalski@kshsaa.org</a>). Bring rules books and the *Preseason Guide* to the area meetings. Attendance cards will be available at the meetings.

#### **Postseason Tournament Application**

Applications can be submitted online and updated until the date applications are due February 7, 2024. Assignments for postseason are based on recommendations from schools, area supervisors and league commissioners.

#### **Postseason Recommendations**

Only officials who have completed the postseason requirements will be available for schools to recommend for postseason. Complete rules meeting, score 90% on exam, attend Area Meeting I and II. Recommendation totals from schools can be viewed on your officials page after March 11.

#### Postseason Assignment Notification – Arbiter

The KSHSAA will be using Arbiter (*ArbiterSports.com*) to notify officials of postseason assignments. Make sure your email and contact information on the KSHSAA website and in Arbiter are correct and match. Eligible officials will be sent an invitation to join KSHSAA Post 104201. The KSHSAA will use ArbiterPay to pay all state officials.

#### **Official Education**

Educational resources are available for officials on the KSHSAA officials page under education. As a 100% state with the NFHS, also known as an Officials Education Services Program state, all officials have the ability to take educational courses at *NFHS.learn*. There are sport specific officiating courses available free for NFOA members, because part of your registration fee pays for you to be an NFOA member you can view these classes. In addition, Kansas officials have the ability to use the NFHS rules book app (*allaccess.nfhs.org*) to download rules books on your mobile device for free.

#### Clinics

KSHSAA Area Supervisors will be conducting clinics for 1<sup>st</sup> through 4<sup>th</sup> year officials. Please see the enclosed flyer for more information. Pre-registration is required. These are the best learning opportunities for officials with zero to three years experience!

#### **Unusual Situations Report Form – Must be completed online**

- Log on as an official and complete the form correctly. It will be emailed to the schools involved and the KSHSAA administrator.
- Only report what happened. Don't tell school personnel or the KSHSAA what actions should be taken.
- All reports are followed up on by the KSHSAA. *ALL EJECTIONS (PLAYER & COACH) MUST BE REPORTED by the next day.*

#### **Ejection Policies**

The Executive Board policy now states that any coach ejected from a contest must complete an online course *Teaching and Modeling Behavior* before the next regularly scheduled contest. Players ejected must also complete a *Sportsmanship* course if ejected from a contest. **It is imperative that we know of any ejections immediately.** 

#### **Ejections for Conduct Towards Officials**

Any participant (player, coach, spectator) who is ejected for making contact with an official or who is ejected for unsporting behavior directed toward an official, shall be subject to a non-appealable suspension from the next contest at that level and for all contests at any level (in that activity) until the suspension has been served. Local school leadership may levy additional sanctions as they deem appropriate. The KSHSAA staff reviews all ejection reports.

#### **Loss of Coaching Box Form – Submit Online**

This form must be submitted each time you have a Loss of Coaching Box situation (direct technical on a coach) at any level. It is on the right hand side as an online submission or you may print it off, scan and email the form to the KSHSAA office.

#### **Weekly Announcements**

Officials should check the KSHSAA website for announcements and rules interpretations. Go to *kshsaa.org/athletics/basketball* to find weekly updates, the link will be sent via email each week.

#### **Probation**

Officials failing to take the required NFHS "open-book" examination and/or attend a KSHSAA rules meeting will be placed on probation for next season. Should any requirements not be met next year, while on probation, the officials will be suspended for not less than one year.

#### **Online Information**

Officials are responsible for making sure personal information is accurate on the Arbiter and KSHSAA websites.

#### **Recruiting & Mentoring Officials**

Please consider helping a new official by working games with them or going with them to games. Young officials should ask veteran officials to observe them and provide constructive feedback.

#### **Basketball Official Uniform**

The proper uniform for basketball officials in Kansas is a short-sleeved, one inch black and white striped "V" neck knit shirt with black cuffs. An undershirt if worn should not be visible. The shirt should be worn inside the pants and the crew shall wear the same design and style. Black slacks, black socks, primarily black shoes with black laces, and if worn a black belt. A black jacket may be worn prior to the game. The black jacket must be without stripes on cuffs and collar and no logos other than KSHSAA or recognized Local Official Association logos.

#### ARBITERSPORTS INFORMATION FOR KSHSAA REGISTERED OFFICIALS

The majority of leagues use ArbiterSports to notify officials of game assignments. The KSHSAA pays for all school league commissioners to use this assigning tool. The KSHSAA will use ArbiterSports to notify all officials of postseason assignments. The KSHSAA DOES NOT assign officials for regular season contests.

Only KSHSAA registered officials will be available for assignment through Arbiter. THEREFORE IT IS IMPERATIVE THAT YOU REGISTER EARLY WITH THE KSHSAA IN ORDER TO BE AVAILABLE FOR ASSIGNMENT BY COMMISSIONERS/LEAGUES AND SCHOOLS USING ARBITER.

Please note the following regarding the ArbiterSports officials assigning system:

- 1. All officials registered with the KSHSAA will be automatically placed in the KSHSAA Administration Arbiter account #103765.
  - You must join this account in order to be assigned games by individual schools.
  - You must join this account in order to be added to sub-groups (commissioner) accounts.
- 2. YOU MUST PROVIDE AN EMAIL ADDRESS WHEN YOU REGISTER WITH THE KSHSAA. After registering with the KSHSAA, login to your ArbiterSports account and check the email address listed. Be sure it is the email address you want to use to receive game assignments through ArbiterSports. You must have an email address in ArbiterSports to receive game assignments.
- 3. As a new official you must complete the KSHSAA New Official Orientation prior to you getting an eligibility period in Arbiter. The link to this meeting comes in your registration confirmation email.
- 4. Officials registering for the first time will be sent a welcome message via email to join the KSHSAA Administration account (103765). Officials must accept this group invitation in order to be added to other groups.
- 5. Officials that were registered for the 2023-2024 school year will remain in Arbiter sports as assignable until the new registration period begins for 2024-2025.
- 6. Once you accept the invitation to be in group #103765 (KSHSAA Administration) other commissioners can choose to add you as an official to their account.
- 7. You will receive a welcome invitation from each sub-group (commissioner) that wishes to add you to their account. You will need to accept each sub-group invitation in order to be assigned by that commissioner.
- 8. In order to remain in the KSHSAA Administration account and be assignable an official **MUST** register with the KSHSAA.
- 9. If an official fails to register with the KSHSAA by the registration deadline the official will show as unregistered in ArbiterSports and will not be able to receive game assignments. ANY EXISTING ASSIGNMENTS AT THIS TIME WILL BE REMOVED.
- 10. In order to not jeopardize your ability to receive games from individual schools or from league commissioners, officials should register with the KSHSAA as quickly as possible after June 1.
- 11. Information on blocking dates, accepting/declining games and other functions of ArbiterSports is available on the ArbiterSports website.
- 12. It is each official's responsibility to keep up to date all contact information (including your email address) in the KSHSAA.org website account and all Arbiter accounts.
- 13. NFHS Learn Educational materials are available at nfhslearn.com. The site includes sport specific online training courses. Kansas is a 100% NFHS state also known as an Officials Education Services Program state, therefore, the cost of these courses is reduced. Officials can also review video of plays on the NFHSLearn.com site. In addition, all officials have access to the NFHS rule book app in the sports they are registered for no cost.
- 14. If you are looking for regular season contests please contact them telling them your experience and dates available. You can find the schools in each league by logging on as an official on the KSHSAA website. After you are logged in, go to Directories>School Directories>View High School Leagues.

The KSHSAA rules testing process for head high school coaches, head middle/junior high school coaches and officials will continue to be administered online only. Officials are required to complete the online exam within the date range for their respective sport(s).

For sports requiring an in-person officials rules meeting there is NO online rules meeting option. YOU MUST ATTEND THE IN-PERSON OFFICIALS RULES MEETING TO RECEIVE RULES MEETING CREDIT. The Officials Rules Meeting Schedule is included in this packet. In 2023-2024 the KSHSAA will also be offering a limited number of in-person rules meetings at select locations across Kansas in the sports of Football and Soccer. Officials registered in Football or Soccer may choose to fulfill their rules meeting requirement online OR at one of the in-person rules meetings listed on the schedule. The dates the online rules meetings are available to receive credit are listed above.

Exception: Track & Field starters must attend the online rules meeting (no in-person meetings offered).

OFFICIALS WHO ARE ALSO HEAD COACHES IN THE SAME ACTIVITY SHOULD CONTACT THE KSHSAA AFTER COMPLETING THEIR OFFICIAL'S ONLINE EXAM TO ENSURE EXAM CREDIT IS APPLIED TO THEIR COACHING POSITION.

### **National Federation of State High School Associations**

### Officials Code of Ethics

Officials at an interscholastic athletic event are participants in the educational development of high school students. As such, they must exercise a high level of self-discipline, independence and responsibility. The purpose of this Code is to establish guidelines for ethical standards of conduct for all interscholastic officials.

**Officials** shall master both the rules of the game and the mechanics necessary to enforce the rules, and shall exercise authority in an impartial, firm and controlled manner.

**Officials** shall work with each other and their state associations in a constructive and cooperative manner.

**Officials** shall uphold the honor and dignity of the profession in all interaction with student-athletes, coaches, athletic directors, school administrators, colleagues, and the public.

**Officials** shall avoid the use of alcohol and tobacco products beginning with the arrival at the competition site until departure following the completion of the contest.

**Officials** shall prepare themselves both physically and mentally, shall dress neatly and appropriately, and shall comport themselves in a manner consistent with the high standards of the profession.

**Officials** shall be punctual and professional in the fulfillment of all contractual obligations.

**Officials** shall remain mindful that their conduct influences the respect that student- athletes, coaches and the public hold for the profession.

**Officials** shall, while enforcing the rules of play, remain aware of the inherent risk of injury that competition poses to student-athletes. Where appropriate, they shall inform event management of conditions or situations that appear unreasonably hazardous.

**Officials** shall take reasonable steps to educate themselves in the recognition of emergency conditions that might arise during the course of competition.

**Officials** shall maintain an ethical approach while participating in forums, chat rooms and all forms of social media.



### **Basketball Bench Conduct and Sportsmanship**

Each basketball season the KSHSAA office receives many questions on acceptable bench conduct by head basketball coaches. The questions stem from what is interpreted as acceptable behavior. This material is intended to offer some insight and guidance.

Officials should permit certain behavior by the head coach who engages in spontaneous reactions to officiating calls and non-calls provided the coach remains in the coaching box and the reaction is not prolonged, profane, vulgar or threatening.

Coaches and bench personnel are expected to adhere to the specific rules set forth in NFHS Rule 10. Repeated or prolonged violations of these rules should result in a technical foul being assessed against the coach or other bench personnel. **More egregious conduct violations, while inside or outside the coaching box, should be properly and consistently penalized with a technical foul without warning.** 

Examples of egregious conduct violations which should be penalized include, but are not limited to, the following:

- 1. Comments directed at or referring to any game official that question the integrity of an official. (Repeated references to the foul count against each team; suggesting an official is "cheating" or "homering" a team, etc.)
- 2. A negative response to a call/no-call including, but not limited to, approaching/charging an official in a hostile, aggressive or otherwise threatening manner; emphatically removing one's coat in a response to a call/no-call; throwing equipment or clothing; thrashing the arms in disgust; running or jumping in disbelief; or other actions deemed to incite undesirable crowd reactions.

**Coaching Box**: Make sure there is a designated coaching box as prescribed in the NFHS rules book. Failure to comply with the rule results in a distinct advantage that is not within the spirit and intent of the rules. The rule is clear and concise. The head coach or any other bench personnel may not be outside the prescribed coaching box except when otherwise permitted by rule. When a coach is out of the coaching box instructing their players, officials must remind the coach to return to the coaching box. This can be done with a couple of sentences in a **relaxed tone** and the coaching box issue has been addressed. This is preventive officiating and can go a long way toward avoiding further problems.

Regardless of the situation, it is in everyone's best interest for coaches and officials to work together to bring about the best possible event for our student-athletes. One key way to achieve this:

- <u>Coaches</u>: Wait until an official makes his way toward you in the normal course of the game or during dead ball periods to make your point in a civil manner in close proximity.
- Officials: When you know the coach wants to speak to you, make your way toward the coach so that they can make their point in a timely and less boisterous manner.

Cooperation from both parties in this manner will result in greater understanding and a better atmosphere for all.


